in a question before the voters to go into effect. Current law requires that the total number 1 of votes cast for and against the question equal or exceed 30% of the total votes cast in the 2 municipality in the last gubernatorial election. The amendment requires instead that the 3 number of votes cast in favor of the question exceed 15% of the total votes cast in the 4 municipality in the last gubernatorial election. Also, while the amendment does not change 5 6 the requirement that a majority of votes cast for and against the proposed change be in favor of it in order for that change to go into effect, the amendment clarifies that blank votes are 7 not counted in that calculation. 8
