Commission membership. Resolved: That, notwithstanding Joint Rule 25 353, the commission consists of 14 members, including: 26 1. Two members of the Senate, appointed by the President of the Senate, who serve 27 on the Joint Standing Committee on Education and Cultural Affairs, including one member 28 of the party holding the largest number of seats in the Legislature and one member of the 29 party holding the 2nd largest number of seats in the Legislature; 30 2. Two members of the House of Representatives, appointed by the Speaker of the 31 House, who serve on the Joint Standing Committee on Education and Cultural Affairs,

including one member of the party holding the largest number of seats in the Legislature

and one member of the party holding the 2nd largest number of seats in the Legislature;

  - 8. The President of the Maine Community College System or the president's designee;
- 9. The Chair of the Maine Community College System Board of Trustees or the chair's designee;
- 10. The Chair of the Maine Maritime Academy Board of Trustees or the chair's designee;
  - 11. The President of the Maine Maritime Academy or the president's designee; and
  - 12. The Commissioner of Education or the commissioner's designee.

In appointing members of the commission, the appointing authorities shall give consideration to race, gender, socioeconomic diversity and geographic diversity.'

Amend the resolve in section 4 in the first line (page 1, line 39 in L.D.) by inserting after the following: "**commission**" the following: '; number of meetings'

Amend the resolve in section 4 in the last line (page 2, line 6 in L.D.) by inserting after the following: "business." the following: 'The commission may not meet more than 8 times.'

Amend the resolve by striking out all of section 7 and inserting the following:

'Sec. 7. Report. Resolved: That, notwithstanding Joint Rule 353, no later than November 4, 2026, the commission shall submit a report that includes its findings and recommendations, including suggested legislation, to the joint standing committee of the Legislature having jurisdiction over education matters. The joint standing committee may report out a bill related to the report to the 133rd Legislature in 2027.'

Amend the resolve by adding before the summary the following:

'Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'

Amend the resolve by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

2 3	This amendment makes the following changes to the Commission to Update Maine's Public Policy on Higher Education.
4	1. It changes the membership from 17 members to 14 members as follows:
5 6	A. It changes the membership from 3 members of the House of Representatives to 2 members;
7 8	B. It removes a member with expertise in higher education policy issues representing a statewide education policy research institute;
9 10	C. It removes a member who is employed as a faculty member at a private college or university in the State;
11 12	D. It removes a member who is a representative of a union representing the faculty of the University of Maine System;
13 14	E. It removes a member who is a representative of a union representing the faculty of the Maine Maritime Academy;
15 16	F. It removes a member who is currently enrolled as a student at a college or university in the State; and
17 18 19	G. It adds 3 members, one member each from the board of trustees of the University of Maine System, the Maine Community College System and the Maine Maritime Academy.
20 21	2. It requires that certain appointments must be recommended by specific organizations.
22	3. It specifies that the commission may meet no more than 8 times.
23	4. It changes the reporting date from December 3, 2025 to November 4, 2026.
24	5. It adds an emergency preamble and emergency clause.
