COMMITTEE AMENDMENT

1 This amendment changes the bill by broadening the disqualification from 2 unemployment benefits in current law for unemployment that is due to a stoppage of 3 work caused by a labor dispute by eliminating the requirement that there is a stoppage of 4 work. Instead, under the amendment, unemployment that is due to a labor dispute is 5 sufficient grounds for a denial of benefits. The amendment also updates the language of 6 the exceptions in current law to this disqualification to reflect the elimination of the 7 stoppage of work requirement.
