11 12	Amend the bill by striking out everything after the title and before the summary and inserting the following:
13 14	'Emergency preamble. Whereas, acts and resolves of the Legislature do no become effective until 90 days after adjournment unless enacted as emergencies; and
15 16	Whereas, the State is facing a crisis due to the rapidly increasing number of opioid related drug overdose deaths; and
17 18 19 20	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now therefore,
21	Be it enacted by the People of the State of Maine as follows:
22	Sec. 1. 22 MRSA §2353, sub-§2, ¶¶A-2 and C-2 are enacted to read:
23	A-2. Until July 1, 2019, a pharmacist may prescribe and dispense naloxone
24	hydrochloride in accordance with protocols established under Title 32, section 13815
25	to an individual at risk of experiencing an opioid-related drug overdose.
26	C-2. Until July 1, 2019, a pharmacist may prescribe and dispense naloxone
27	hydrochloride in accordance with protocols established under Title 32, section 13813
28 29	to a member of an individual's immediate family or a friend of the individual or to another person in a position to assist the individual if the individual is at risk or
30	experiencing an opioid-related drug overdose.
31 32	Sec. 2. 32 MRSA §13815, as enacted by PL 2015, c. 508, §5, is repealed and the following enacted in its place:

1	§13815. Authorization
2	1. Rules for dispensing naloxone hydrochloride. The board by rule shall establish
3	procedures and standards for authorizing pharmacists to dispense naloxone hydrochloride
4	in accordance with Title 22, section 2353. The rules must establish adequate training
5	requirements and protocols for dispensing naloxone hydrochloride by prescription drug
6	order or standing order or pursuant to a collaborative practice agreement. Rules adopted
7	under this subsection are routine technical rules as defined in Title 5, chapter 375,
8	subchapter 2-A. A pharmacist authorized by the board pursuant to this subsection to
9	dispense naloxone hydrochloride may dispense naloxone hydrochloride in accordance
10	with Title 22, section 2353.
11	2. Rules for prescribing and dispensing naloxone hydrochloride. The board by
12	rule shall establish standards for authorizing pharmacists to prescribe and dispense
13	naloxone hydrochloride in accordance with Title 22, section 2353, subsection 2,
14	paragraphs A-2 and C-2. The rules must establish adequate training requirements and
15	protocols for prescribing and dispensing naloxone hydrochloride when there is no
16	prescription drug order, standing order or collaborative practice agreement authorizing
17	naloxone hydrochloride to be dispensed to the intended recipient. Rules adopted under
18	this subsection are routine technical rules as defined in Title 5, chapter 375, subchapter
19	2-A. A pharmacist authorized by the board pursuant to this subsection to prescribe and
20	dispense naloxone hydrochloride may prescribe and dispense naloxone hydrochloride in
21	accordance with Title 22, section 2353, paragraphs A-2 and C-2.
22	This subsection is repealed July 1, 2019.
23	Emergency clause. In view of the emergency cited in the preamble, this
24	legislation takes effect when approved.'

26	This amendment, which is the majority report of the committee, adds an emergency
27	preamble and emergency clause and provides for the authority of a pharmacist to

This amendment, which is the majority report of the committee, adds an emergency preamble and emergency clause and provides for the authority of a pharmacist to prescribe naloxone hydrochloride in accordance with rules adopted by the Maine Board of Pharmacy. This authority expires on July 1, 2019.
