Amend the resolve by striking out all of section 5 and inserting the following:

'Sec. 5. Duties. Resolved: That the task force shall meet 4 times in order to 7 conduct a comprehensive study on performance-based contracting and social impact 8 9 partnerships for public education. In performing its work, the task force shall research the various aspects of the issues related to using performance-based contracting and social 10 11 impact partnerships to support public education. The task force shall make recommendations regarding the viability of implementing performance-based contracting 12 and social impact partnerships with private and governmental entities to support public 13 14 education; and be it further'

15 Amend the resolve by striking out all of section 7 and inserting the following:

16 'Sec. 7. Outside funding for task force activities. Resolved: That the task force may seek outside funds to provide staff support, consulting or other services or to 17 fund the costs of carrying out the duties and requirements of the task force. Contributions 18 to support the work of the task force may not be accepted from any party having a 19 pecuniary or other vested interest in the outcome of the matters being studied. Any 20 person, other than a state agency, desiring to make a financial or in-kind contribution 21 shall certify to the Legislative Council that it has no pecuniary or other vested interest in 22 the outcome of the task force's activities. Such a certification must be made in the 23 manner prescribed by the Legislative Council. All contributions are subject to approval 24 by the Legislative Council. All funds accepted must be forwarded to the Executive 25 26 Director of the Legislative Council along with an accounting record that includes the amount of the funds, the date the funds were received, from whom the funds were 27 received and the purpose of and any limitation on the use of the funds. The Executive 28 Director of the Legislative Council shall administer any funds received by the task force; 29 30 and be it further

Sec. 8. Report. Resolved: That, no later than January 15, 2017, the task force shall submit a report that includes its findings and recommendations, including suggested legislation, for presentation to the First Regular Session of the 128th Legislature. The joint standing committee of the Legislature having jurisdiction over education and cultural affairs may report out a bill to the First Regular Session of the 128th Legislature.'

SUMMARY

This amendment reduces the membership of the Task Force on Public-private Partnerships To Support Public Education from 17 members to 12 members. This amendment removes the requirement that the task force develop a pilot project for the implementation of performance-based contracting and social impact bonding with private and governmental entities to support public education and instead requires the task force to make recommendations regarding the viability of implementing performance-based contracting and social impact partnerships with private and governmental entities to
