COMMITTEE AMENDMENT “ ” to H.P. 1156, L.D. 1738, “An Act to Establish the Biohazard Waste Disposal Grant Program to Support Public Health Efforts in the State”

Amend the bill in section 2 in §1342 in subsection 1 in the 4th line (page 1, line 11 in L.D.) by striking out the following: “, referred to in this section as “the center,””

Amend the bill in section 2 in §1342 in subsection 1 in the 5th line (page 1, line 12 in L.D.) by striking out the following: “center” and inserting the following: ‘Maine Center for Disease Control and Prevention’

Amend the bill in section 2 in §1342 in subsection 1 in the 8th line (page 1, line 15 in L.D.) by striking out the following: “center” and inserting the following: ‘Maine Center for Disease Control and Prevention’

Amend the bill in section 2 in §1342 by inserting after subsection 1 the following:

2. Fund established. The Biohazard Waste Disposal Grant Program Fund is established within the department as a nonlapsing fund for the purposes specified in this section. The fund consists of any money received as contributions, grants or appropriations from private and public sources. The fund, to be accounted for within the department, must be held separate and apart from all other money, funds and accounts.’

Amend the bill in section 2 in §1342 in subsection 2 in the first line (page 1, line 17 in L.D.) by striking out the following: “center” and inserting the following: ‘Maine Center for Disease Control and Prevention’

Amend the bill in section 2 in §1342 in subsection 3 in the first line (page 1, line 21 in L.D.) by striking out the following: “center” and inserting the following: ‘Maine Center for Disease Control and Prevention’

Amend the bill in section 2 in §1342 in subsection 4 in the first line (page 1, line 27 in L.D.) by striking out the following: “center” and inserting the following: ‘Maine Center for Disease Control and Prevention’

Amend the bill in section 2 in §1342 in subsection 6 in the first line (page 2, line 8 in L.D.) by striking out the following: "center" and inserting the following: 'Maine Center for Disease Control and Prevention'

Amend the bill in section 2 in §1342 by renumbering the subsections to read consecutively.

Amend the bill by inserting after section 2 the following:

'Sec. 3. Appropriations and allocations. The following appropriations and allocations are made.
