I	SUMMARY
2	This amendment removes from membership on the commission established in the
3	resolve the Director of the Efficiency Maine Trust, or the director's designee, and the
4	chair of the Public Utilities Commission, or the chair's designee. It removes language that
5	limits who may provide public input. It removes the requirement that the commission hire
6	a 3rd party to help with data collection, research and best practices and to develop policy
7	recommendations. Lastly, it removes language that requires the commission to be funded
8	by federal funds provided by the United States Department of Energy.
