COMMITTEE AMENDMENT “ ” to H.P. 1166, L.D. 1569, “An Act Regarding an Excise Tax on Water Extracted for Commercial Bottling”

Amend the bill by striking out the title and substituting the following:

**'Resolve, Establishing the Commission To Study the Role of Water as a Resource in the State of Maine'**

Amend the bill by striking out everything after the title and inserting the following:

**Preamble.** Whereas, water is an invaluable resource for the people and businesses in this State; and

**Whereas,** the use of water in the State for various purposes has raised questions regarding the continuing availability and quality of water resources; now, therefore, be it

**Sec. 1. Commission established. Resolved:** That the Commission To Study the Role of Water as a Resource in the State of Maine, referred to in this resolve as "the commission," is established.

**Sec. 2. Commission membership. Resolved:** That, notwithstanding Joint Rule 353, the commission consists of 16 members appointed as follows.

- 1. Four members appointed by the President of the Senate, including:
  - A. Two members of the Senate, including a member from each of the 2 parties holding the largest number of seats in the Legislature;
  - B. One member of the public residing in northern Maine; and
  - C. One member representing the interests of persons who bottle or package water for commercial sale.
- 2. Four members appointed by the Speaker of the House of Representatives, including:
  - A. Two members of the House of Representatives, including a member from each of the 2 parties holding the largest number of seats in the Legislature;

- 1 B. One member of the public residing in western Maine; and  
2 C. One member representing the interests of businesses that use water in  
3 manufacturing or the provision of items or services for sale.  
4 3. Eight members appointed by and agreed upon by both the President of the Senate  
5 and the Speaker of the House, including:  
6 A. One member representing the Office of Policy Innovation and the Future;  
7 B. Two members who are members of federally recognized Indian nations, tribes or  
8 bands in the State based on the joint recommendation of the tribal governments of the  
9 Aroostook Band of Micmacs, the Houlton Band of Maliseet Indians, the  
10 Passamaquoddy Tribe at Motahkomikuk, the Passamaquoddy Tribe at Sipayik and the  
11 Penobscot Nation. If the tribal governments do not make unanimous joint  
12 recommendations, the President of the Senate and the Speaker of the House shall  
13 appoint 2 members of a federally recognized Indian nation, tribe or band in the State;  
14 C. One member representing the Department of Health and Human Services, Maine  
15 Center for Disease Control and Prevention, division of environmental health, drinking  
16 water program;  
17 D. One member representing the interests of municipal water utilities;  
18 E. One member representing the State Geologist;  
19 F. One member representing organizations involved in protection of the environment;  
20 and  
21 G. One member representing the Office of the Attorney General with an interest in  
22 water rights law.

23 **Sec. 3. Chairs. Resolved:** That the first-named Senate member is the Senate chair  
24 and the first-named House of Representatives member is the House chair of the  
25 commission.

26 **Sec. 4. Appointments; convening of commission. Resolved:** That all  
27 appointments must be made no later than 30 days following the effective date of this  
28 resolve. The appointing authorities shall notify the Executive Director of the Legislative  
29 Council once all appointments have been completed. After appointment of all members,  
30 the chairs shall call and convene the first meeting of the commission. If 30 days or more  
31 after the effective date of this resolve a majority of but not all appointments have been  
32 made, the chairs may request authority and the Legislative Council may grant authority for  
33 the commission to meet and conduct its business.

34 **Sec. 5. Duties. Resolved:** That the commission shall study issues associated with  
35 the role of water resources in the State and the nature and extent of infrastructure involved  
36 in the use and delivery of water resources including:

- 37 A. The extent of water resources available in the State;  
38 B. Legal principles regarding the ownership of water resources in the State;  
39 C. The extent to which water resources will be needed in the State and nation in the  
40 future for household, government, business, commercial and other purposes;

- 1 D. The quality of available water resources and the need for measures to protect water
- 2 quality;
- 3 E. The extent of transportation of water within the State and exportation of water from
- 4 the State;
- 5 F. The sustainability of aquifers within the State;
- 6 G. The nature and use of natural resource extraction taxes in other states and the
- 7 advantages and disadvantages of enacted natural resource extraction taxes in the State;
- 8 and
- 9 H. The relationship between water resources and climate change in the State, including
- 10 an analysis of what actions other states are taking on this issue.

11 The commission shall develop recommendations to ensure that there is adequate clean, safe  
 12 and accessible drinking water for the State's residents and to meet the needs of commercial  
 13 and business interests now and in the future. The commission shall identify the need for  
 14 additional state resources to implement its recommendations and shall make a  
 15 recommendation regarding the positive and negative aspects of a tax on water extraction.

16 **Sec. 6. Staff assistance. Resolved:** That the Legislative Council shall provide  
 17 necessary staffing services to the commission, except that Legislative Council staff support  
 18 is not authorized when the Legislature is in regular or special session.

19 **Sec. 7. Report. Resolved:** That, no later than March 15, 2022, the commission  
 20 shall submit a report that includes its findings and recommendations, including suggested  
 21 legislation, for presentation to the Joint Standing Committee on Taxation during the Second  
 22 Regular Session of the 130th Legislature. The committee may present legislation related  
 23 to the report of the commission to the Second Regular Session of the 130th Legislature.

24 **Sec. 8. Appropriations and allocations. Resolved:** That the following  
 25 appropriations and allocations are made.

28 Initiative: Appropriates one-time funds to the Legislature for the costs of securing outside  
 29 part-time staffing or outside data analyses to support the work of the Commission To Study  
 30 the Role of Water as a Resource in the State of Maine.
