2	This amendment replaces the bill with a resolve. The amendment directs the Director
3	of the Maine Criminal Justice Academy to convene a working group that includes
4	representatives from each federally recognized Indian nation, tribe or band in the State that
5	has law enforcement officers to study the eligibility of certain tribal law enforcement
6	officers to receive waivers for the academy's basic law enforcement training requirements.
7	The academy is required to submit a report by January 1, 2026 to the Joint Standing
8	Committee on Criminal Justice and Public Safety, which may submit legislation based on
9	the report to the Second Regular Session of the 132nd Legislature.
