In making the appointment pursuant 21 to this subsection, the Senate Minority Leader shall endeavor to appoint a member having 22 expertise in areas or backgrounds listed in section 6; 23 3. Three members of the House of Representatives appointed by the Speaker of the 24 House from the party holding the largest number of seats in the House. In making the 25 appointments pursuant to this subsection, the Speaker of the House shall endeavor to 26 appoint members having expertise in areas or backgrounds listed in section 6; 27 4. Three members of the House of Representatives appointed by the House Minority 28 Leader from the party holding the 2nd largest number of seats in the House.
