Amend the resolve in section 1 in section 2 in the 2nd line (page 1, line 20 in L.D.) by striking out the following: "25" and inserting the following: '27'

Amend the resolve in section 1 in section 2 in subsection 25 in the first line (page 2, line 31 in L.D.) by striking out the following: "and"

Amend the resolve in section 1 in section 2 in subsection 26 in the first line (page 2, line 32 in L.D.) by striking out the following: "House." and inserting the following: 'House;'

Amend the resolve in section 1 in section 2 by inserting after subsection 26 the following:

'27. A representative of a state-based organization that promotes Acadian culture in the State, appointed by the President of the Senate; and

28. A representative of a state-based organization that promotes Jewish heritage in the State, appointed by the Speaker of the House.'

Amend the resolve in section 1 in section 2 in the first indented paragraph in the first line (page 2, line 33 in L.D.) by striking out the following: "25" and inserting the following: '27'

Amend the resolve in section 4 in section 8 in the first indented paragraph in the first line (page 3, line 27 in L.D.) by inserting after the following: "commission" the following: 'not otherwise compensated by their employer or other entities whom they represent'

Amend the resolve by inserting after section 5 the following:

**'Sec. 6. Appropriations and allocations. Resolved:** That the following appropriations and allocations are made.
