Amend the bill in Part A in section 1 in §1203-C in subsection 23 in the 11th line (page 4, line 35 in L.D.) by inserting after the following: "230050044021028," the following: '230050044021029.'

Amend the bill in Part A in section 1 in §1203-C in subsection 25 in the 34th line (page 5, line 34 in L.D.) by striking out the following: "230050044021029,"

Amend the bill in Part A in section 1 in §1203-C in subsection 28 in the last 3 lines (page 9, lines 13 to 15 in L.D.) by striking out the following: "; and the following census units in the minor civil division of Long Island: Blocks 230059900000006, 230059900000007, 230059900000011, 230059900000012, 230059900000013 and 230059900000017"

Amend the bill in Part B in section 1 in §1204-C in subsection 24 in the 28th line (page 20, line 32 in L.D.) by inserting after the following: "230190062002009," the following: '230190062002010.'

Amend the bill in Part B in section 1 in §1204-C in subsection 25 in the 13th line (page 21, line 1 in L.D.) by striking out the following: "230190062002010,"

1 Amend the bill in Part B in section 1 in §1204-C in subsection 107 in the last line (page

4 Amend the bill in Part D by inserting before section 1 the following:

5 '**Sec. D-1. 30-A MRSA §66-C**, as enacted by PL 2021, c. 492, §1 and c. 506, §1, is  
6 repealed.'

7 Amend the bill in Part D in section 1 in §67 by striking out all of subsection 4 (page  
8 88, lines 17 to 31 in L.D.) and inserting the following:

9 **'4. Creation of Franklin County Commissioner Districts.** Franklin County is  
10 divided into districts as follows.

11 A. Until November 5, 2024, Franklin County is divided into the following 3 districts.

12 (1) Commissioner District Number 1 consists of the minor civil divisions and  
13 unorganized territories of Carthage, Dallas Plantation, Jay, Rangeley Plantation,  
14 Sandy River Plantation, South Franklin, Weld, West Central Franklin and Wilton.  
15 The term of office of the commissioner from this district expires in 2024.

16 (2) Commissioner District Number 2 consists of the minor civil divisions of  
17 Chesterville, Farmington and Temple. The term of office of the commissioner from  
18 this district expires in 2024.

19 (3) Commissioner District Number 3 consists of the minor civil divisions and  
20 unorganized territories of Avon, Carrabassett Valley, Coplin Plantation, East  
21 Central Franklin, Eustis, Industry, Kingfield, New Sharon, New Vineyard, North  
22 Franklin, Phillips, Rangeley, Strong and Wyman Township. The term of office of  
23 the commissioner from this district expires in 2022, and again in 2024.

24 B. Beginning November 5, 2024, Franklin County is divided into the following 5  
25 districts.

26 (1) Commissioner District Number 1 consists of the minor civil divisions of  
27 Temple and Wilton; and the following census units in the minor civil division of  
28 Farmington: Block 4029, Block 4030, Block 4031, Block 4032, Block 4033, Block  
29 4034, Block 4035, Block 4037, Block 4038, Block 4039, Block 4040, Block 4041,  
30 Block 4042, Block 4043, Block 4044, Block 4045, Block 4046, Block 4047, Block  
31 4048 and Block 4049 of Census Tract 9712.01; and Block 2000, Block 2001, Block  
32 2002, Block 2003, Block 2004, Block 2005, Block 2006, Block 2007, Block 2008,  
33 Block 2009, Block 2010, Block 2011, Block 2012, Block 2013, Block 2014, Block  
34 2015, Block 2016, Block 2017, Block 2018, Block 2019, Block 2020 and Block  
35 2021 of Census Tract 9712.02. The term of office of the commissioner from this  
36 district expires in 2028 and every 4 years thereafter.

37 (2) Commissioner District Number 2 consists of the following census units in the  
38 minor civil division of Farmington: Block 1000, Block 1001, Block 1002, Block  
39 1003, Block 1004, Block 1005, Block 1006, Block 1007, Block 1008, Block 1009,  
40 Block 1010, Block 2000, Block 2001, Block 2002, Block 2003, Block 2004, Block  
41 2005, Block 2006, Block 2007, Block 3000, Block 3001, Block 3002, Block 3003,  
42 Block 3004, Block 3005, Block 3006, Block 3007, Block 3008, Block 3009, Block  
43 3010, Block 3011, Block 3012, Block 3013, Block 4000, Block 4001, Block 4002,

1           Block 4003, Block 4004, Block 4005, Block 4006, Block 4007, Block 4008, Block  
2           4009, Block 4010, Block 4011, Block 4012, Block 4013, Block 4014, Block 4015,  
3           Block 4016, Block 4017, Block 4018, Block 4019, Block 4020, Block 4021, Block

13           Block 4019, Block 4020, Block 4021, Block 4022, Block 4023, Block 4024, Block  
14           4025, Block 4026, Block 4027, Block 4028, Block 4029 and Block 4030 of Census  
15           Tract 9712.02. The term of office of the commissioner from this district expires  
16           in 2028 and every 4 years thereafter.

17           (3) Commissioner District Number 3 consists of the minor civil divisions and  
18           unorganized territories of Avon, Carthage, Coplin Plantation, Eustis, North  
19           Franklin, Phillips, Rangeley, Rangeley Plantation, Sandy River Plantation, South  
20           Franklin, Strong, Weld and West Central Franklin. The term of office of the  
21           commissioner from this district expires in 2028 and every 4 years thereafter.

22           (4) Commissioner District Number 4 consists of the minor civil divisions and  
23           unorganized territories of Carrabassett Valley, Dallas Plantation, East Central  
24           Franklin, Industry, Kingfield, New Sharon, New Vineyard and Wyman Township.  
25           The term of office of the commissioner from this district expires in 2026 and every  
26           4 years thereafter.

27           (5) Commissioner District Number 5 consists of the minor civil divisions of  
28           Chesterville and Jay. The term of office of the commissioner from this district  
29           expires in 2026 and every 4 years thereafter.'

30           Amend the bill in Part D in section 1 in §67 in subsection 12 in paragraph B in the 2nd  
31           line (page 91, line 18 in L.D.) by striking out the following: "2024" and inserting the  
32           following: '2022'

33           Amend the bill in Part D in section 1 in §67 in subsection 12 in paragraph C in the last  
34           line (page 91, line 23 in L.D.) by striking out the following: "2022" and inserting the  
35           following: '2024'

36           Amend the bill by relettering or renumbering any nonconsecutive Part letter or section  
37           number to read consecutively.

## SUMMARY

38           This amendment makes the following changes to the bill, which codifies in the Maine  
39           Revised Statutes the unanimous plan submitted by the apportionment commission and  
40           enacted by the Legislature in the Second Special Session of the 130th Legislature.  
41

42           1. To correct technical errors in the apportionment commission's plan discovered by  
43           the Office of the Secretary of State when the office applied the new districts to the central

1 voter registration system in preparation for upcoming elections, this amendment corrects  
2 census units in State Senate Districts 23, 25 and 26 and in State House of Representative  
3 Districts 24, 25, 28 and 107.

47 2. This amendment incorporates the changes to the Franklin County Commissioner  
48 Districts enacted in Public Law 2021, chapter 492, dividing Franklin County into 5 county  
49 commissioner districts beginning November 5, 2024.

50 3. This amendment incorporates the changes to the termination dates of 2 of the  
51 Sagadahoc County Commissioner Districts, as enacted in Public Law 2021, chapter 506.
