5	This amendment authorizes the Chief Judge of the District Court to issue an order,
6	which must be made publicly available, reallocating any municipality or unorganized
7	territory between the Western Aroostook and Eastern Aroostook judicial divisions of the
8	State. The amendment also directs the Chief Judge to submit a report by January 15, 2026
9	to the Joint Standing Committee on Judiciary with recommendations for redrawing the
0	geographic boundaries between any of the judicial divisions in the State and authorizes the
1	committee to report out legislation based on the report.
2	The amendment also adds an appropriations and allocations section recognizing the
