COMMITTEE AMENDMENT “ ” to S.P. 52, L.D. 165, Bill, “An Act To Prohibit the Use of Handheld Phones and Devices While Driving”

Amend the bill by striking out everything after the enacting clause and inserting the following:

Sec. 1. 4 MRSA §20, as amended by PL 2011, c. 131, §1, is further amended to read:

§20. Provide for collection of fines and fees from money collected

The Chief Justice of the Supreme Judicial Court shall plan and implement arrangements for the collection of overdue fines and fees due the state courts, the costs of which may be paid from money collected. These arrangements may include but are not limited to: Employing special project clerks, assistants and other staff; contracting with state agencies; contracting for special or private debt collection services; purchasing necessary equipment; and compensating state, county and municipal law enforcement agencies for services provided.

The Chief Justice of the Supreme Judicial Court may implement arrangements for the use of fines and fees collected under Title 29-A, section 2121 to pay the costs of processing traffic violations under that section and handling the fines or fees. These arrangements may include employing an assistant clerk.

Sec. 2. 23 MRSA §4210-G is enacted to read:

§4210-G. Supplemental Transportation Fund

1. Fund created. The Supplemental Transportation Fund, referred to in this section as "the fund," is established as a nonlapsing fund in the Department of Transportation.

2. Use of funds. Money deposited into the fund may be used by the Department of Transportation for transportation-related projects and services.

1 3. Source of funds. Money deposited in the fund includes, but is not limited to, fine
2 revenue transferred into the fund pursuant to Title 29-A, section 2121, subsection 4. The
3 Supplemental Transportation Fund may accept funds from other sources.

4 **Sec. 3. 29-A MRSA §101, sub-§§26-C, 35-B and 80-B** are enacted to read:

5 26-C. Handheld electronic device. "Handheld electronic device" means any
6 handheld electronic device or portable electronic device that is not part of the operating
7 equipment of the motor vehicle, including but not limited to an electronic game, a device
8 for sending or receiving electronic mail, a text messaging device or a computer.
9 "Handheld electronic device" does not include a:

10 A. Device for communication over a citizens band radio service as defined in 47
11 Code of Federal Regulations, Section 95.303, the multi-use radio service as defined
12 in 47 Code of Federal Regulations, Section 95.2703 or a land mobile radio service as
13 defined in 47 Code of Federal Regulations, Section 90.7; or

14 B. Personal medical device necessary to monitor or regulate a person's medical
15 condition, including but not limited to an insulin pump or heart monitor.

16 35-B. Mobile telephone. "Mobile telephone" means a device used to access a
17 wireless telephone service.

18 80-B. Text messaging. "Text messaging" means reading or manually composing
19 electronic communications, including text messages, instant messages and electronic
20 mail, using a handheld electronic device. "Text messaging" does not include using a
21 global positioning or navigation system.

22 **Sec. 4. 29-A MRSA §1304, sub-§1, ¶I**, as amended by PL 2015, c. 113, §1, is
23 further amended to read:

24 I. A person who has been issued a learner's permit may not operate a motor vehicle
25 on a public way while using, manipulating, talking into or otherwise interacting with
26 a handheld electronic device or mobile telephone, including but not limited to when
27 the motor vehicle is temporarily stationary because of traffic, a traffic light or a stop
28 sign. For the purpose of this paragraph, the following terms have the following
29 meanings:

30 A person who has been issued a learner's permit may use, manipulate, talk into or
31 otherwise interact with a handheld electronic device or mobile telephone while in the
32 operator's seat of a motor vehicle if the person has pulled the motor vehicle over to
33 the side of, or off, a public way and has halted in a location where the motor vehicle
34 can safely remain stationary.

35 ~~(1) "Handheld electronic device" means any handheld electronic device that is~~
36 ~~not part of the operating equipment of the motor vehicle, including but not~~

13 or otherwise interacting with a handheld electronic device or mobile telephone,
14 including but not limited to when the motor vehicle is temporarily stationary because
15 of traffic, a traffic light or a stop sign.

16 A person under 18 years of age who has been issued a driver's license may use,
17 manipulate, talk into or otherwise interact with a handheld electronic device or
18 mobile telephone while in the operator's seat of a motor vehicle if the person has
19 pulled the motor vehicle over to the side of, or off, a public way and has halted in a
20 location where the motor vehicle can safely remain stationary.

21 For the purpose of this paragraph, the following terms have the following meanings.

22 ~~(1) "Handheld electronic device" means any handheld electronic device that is~~
23 ~~not part of the operating equipment of the motor vehicle, including but not~~

41 ~~beyond the person's 18th birthday.~~

3 **11-A. Portable electronic device.** "Portable electronic device" means an electronic
4 device that is portable in nature, including but not limited to a device for sending or
5 receiving e-mail, a text messaging device, a ~~cellular~~ mobile telephone and a computer.

6 **Sec. 8. 29-A MRSA §2116**, as amended by PL 2015, c. 113, §§4 and 5, is
7 repealed.

8 **Sec. 9. 29-A MRSA §2119**, as amended by PL 2013, c. 188, §1 and c. 381, Pt. B,

10 **§2119. Text messaging while operating motor vehicle; prohibition**

11 **1. Definitions.** ~~As used in this section, unless the context otherwise indicates, the~~
12 ~~following terms have the following meanings.~~

13 A. ~~"Cellular telephone" means a device used to access wireless telephone service.~~

14 B. ~~"Portable electronic device" means any portable electronic device that is not part~~
15 ~~of the operating equipment of a motor vehicle, including but not limited to an~~
16 ~~electronic game, device for sending or receiving e-mail, text messaging device,~~
17 ~~cellular telephone and computer.~~

18 C. ~~"Text messaging" means reading or manually composing electronic~~

28 **2. Prohibition.** A person may not operate a motor vehicle on a public way while
29 engaging in text messaging, including but not limited to when the motor vehicle is
30 temporarily stationary because of traffic, a traffic light or a stop sign.

31 A person may engage in text messaging while in the operator's seat of a motor vehicle if
32 the person has pulled the motor vehicle over to the side of, or off, a public way and has
33 halted in a location where the motor vehicle can safely remain stationary.

34 Nothing in this section prohibits a person employed as a commercial driver or a school
35 bus driver from using a handheld electronic device or mobile telephone within the scope
36 of the person's employment as permitted under Federal Motor Carrier Safety
37 Administration regulations.

38 **3. Penalties.** The following penalties apply to a violation of this section.

39 A. A person who violates this section commits a traffic infraction for which a fine of
40 not less than \$250 may be adjudged.

1 B. A person who violates this section after previously having been adjudicated as
2 violating this section within a 3-year period commits a traffic infraction for which a
3 fine of not less than \$500 may be adjudged, and the Secretary of State shall suspend
4 the license of that person without right to hearing. The minimum periods of license
5 suspension are:

6 (1) Thirty days, if the person has 2 adjudications for a violation of this section
7 within a 3-year period;

8 (2) Sixty days, if the person has 3 adjudications for a violation of this section
9 within a 3-year period; and

10 (3) Ninety days, if the person has 4 or more adjudications for a violation of this
11 section within a 3-year period.

12 For the purposes of this paragraph, an adjudication has occurred within a 3-year
13 period if the date of the new conduct is within 3 years of the date of a docket entry of
14 adjudication of a violation of this section.

15 **Sec. 10. 29-A MRSA §2121** is enacted to read:

16 **§2121. Use of mobile telephones and handheld electronic devices while operating**
17 **motor vehicles prohibited**

18 **1. Prohibition.** A person may not operate a motor vehicle on a public way while
19 using, manipulating, talking into or otherwise interacting with a handheld electronic
20 device or mobile telephone, including but not limited to the use of a handheld electronic
21 device or mobile telephone while the vehicle is temporarily stationary because of traffic,
22 a traffic light or a stop sign, unless:

23 A. The person, other than a person who is operating with a learner's permit issued
24 pursuant to section 1304, is using a mobile telephone or handheld electronic device in
25 order to communicate with law enforcement or emergency services personnel under
26 emergency circumstances. For the purposes of this paragraph, "emergency
27 circumstances" means circumstances in which there is an immediate threat to the
28 health or well-being of any person;

29 B. The person is using a mobile telephone or handheld electronic device in hands-
30 free mode as permitted under subsection 2; or

31 C. The person is employed as a commercial driver or a school bus driver and is using
32 a handheld electronic device or mobile telephone within the scope of the person's
33 employment as permitted under Federal Motor Carrier Safety Administration
34 regulations.

35 A person who has pulled a motor vehicle to the side of, or off, a public way and has
36 halted in a location where the motor vehicle can safely remain stationary may use,
37 manipulate, talk into or otherwise interact with a handheld electronic device or mobile
38 telephone.

39 **2. Hands-free mode.** A person who has attained 18 years of age and is not
40 operating with an intermediate license issued pursuant to section 1311 or a learner's
41 permit issued pursuant to section 1304 may use a mobile telephone or handheld electronic

1 device while operating a motor vehicle if the mobile telephone or handheld electronic
 2 device is being used in hands-free mode.

3 The operator of a motor vehicle may use a hand to activate or deactivate a feature or
 4 function of a mobile telephone or handheld electronic device that is in hands-free mode
 5 and mounted or affixed to the vehicle in a location that does not interfere with the
 6 operator's view of the road if the feature or function activated requires only a single
 7 swipe, tap or push of the operator's finger.

8 For the purposes of this section, "hands-free mode" means the manner of use of a mobile
 9 telephone or handheld electronic device without use of either hand by employing an
 10 internal feature of, or an attachment to, the telephone or device.

11 **3. Penalty.** A person who violates this section commits a traffic infraction for which
 12 a fine of not less than \$50 for the first offense and not less than \$250 for a 2nd or
 13 subsequent offense may be adjudged.

14 **4. Supplemental Transportation Fund.** All fines collected under this section, other
 15 than amounts paid pursuant to Title 4, section 20, must be deposited into the
 16 Supplemental Transportation Fund established under Title 23, section 4210-G.

17 Nothing in this section requires the deposit into the Supplemental Transportation Fund of
 18 any penalty or surcharge imposed by a court, including but not limited to a surcharge
 19 imposed pursuant to Title 4, section 18-A or 1057.

20 **Sec. 11. Appropriations and allocations.** The following appropriations and
 21 allocations are made.

19 Amend the bill by relettering or renumbering any nonconsecutive Part letter or
20 section number to read consecutively.

21 **SUMMARY**

22 This amendment makes the following changes to the bill.

23 1. It creates a fund within the Department of Transportation for fine revenue
24 collected in the enforcement of the prohibition on the use of handheld electronic devices
25 while operating a motor vehicle on a public way.

26 2. It makes definitions uniform across the Maine Revised Statutes, Title 29-A for
27 restrictions on the use of handheld electronic devices and mobile telephones and on
28 texting by drivers, drivers operating with an intermediate license and drivers operating
29 with a learner's permit.

30 3. It clarifies that there is no exception for using a handheld electronic device or
31 mobile telephone while a motor vehicle is stopped in traffic, but does permit use when a
32 car is pulled over in a safe location.

33 4. It incorporates exceptions for radios, hands-free features, medical devices, ignition
34 interlock devices, which are part of the operating equipment of the motor vehicle, and
35 electronic logging devices and other equipment permitted under Federal Motor Carrier
36 Safety Administration regulations.
