20 SUMMARY

This amendment, which is the minority report of the committee, replaces the bill, which is a concept draft, and changes the title. The amendment:

- 1. Provides that the prohibition on the possession and discharge of a firearm on school property does not apply to a law enforcement official who retired in good standing and is currently employed by the public school or private school approved for tuition purposes and has successfully completed the State's training standard within the last year.
- 2. Requires the Department of Education to convene a stakeholder group to study long-term solutions regarding school safety, including the use and funding of school resource officers, the role of the Maine School Safety Center and a recommendation on contracting for a 3rd-party gap analysis and forensic audit. The department is required to report back to the Joint Standing Committee on Education and Cultural Affairs no later than January 2, 2024 on the study. The committee may report out a bill related to the study to the Second Regular Session of the 131st Legislature.
