COMMITTEE AMENDMENT “ ” to S.P. 174, L.D. 513, Bill, “An Act To Eliminate the State Income Tax for Maine Public Employees Retirement System Pensions”

Amend the bill by striking out the title and substituting the following:

'An Act To Provide Equity in the State Income Tax Deduction for Maine Public Employees Retirement System Pensions'

Amend the bill by striking out everything after the enacting clause and before the summary and inserting the following:

'Sec. 1. 36 MRSA §5122, sub-§2, ¶M-2, as amended by PL 2015, c. 382, §2 and c. 390, §8, is further amended to read:

M-2. For tax years beginning on or after January 1, 2016:

(1) For each individual who is a primary recipient of retirement plan benefits, the reduction is the sum of:

(a) Excluding military retirement plan benefits, an amount that is the lesser of:

(i) The aggregate of retirement plan benefits under employee retirement plans or individual retirement accounts included in the individual’s federal adjusted gross income; and

(ii) The pension deduction amount reduced by the total amount of the individual’s social security benefits and railroad retirement benefits paid by the United States, but not less than \$0; and

(b) An amount equal to the aggregate of retirement benefits under military retirement plans included in the individual’s federal adjusted gross income; and

COMMITTEE AMENDMENT

1 (2) For purposes of this paragraph, the following terms have the following
2 meanings.

3 (a) "Employee retirement plan" means a state, federal or military retirement
4 plan or any other retirement benefit plan established and maintained by an
5 employer for the benefit of its employees under the Code, Section 401(a),
6 Section 403 or Section 457(b), except that distributions made pursuant to a
7 Section 457(b) plan are not eligible for the deduction provided by this
8 paragraph if they are made prior to age 55 and are not part of a series of
9 substantially equal periodic payments made for the life of the primary
10 recipient or the joint lives of the primary recipient and that recipient's
11 designated beneficiary.

12 (b) "Individual retirement account" means an individual retirement account
13 under Section 408 of the Code, a Roth IRA under Section 408A of the Code,
14 a simplified employee pension under Section 408(k) of the Code or a simple
15 retirement account for employees under Section 408(p) of the Code.

16 (c) "Military retirement plan" means retirement plan benefits received as a
17 result of service in the active or reserve components of the Army, Navy, Air
18 Force, Marines or Coast Guard.

19 (d) "Pension deduction amount" means \$10,000, except that, for tax years
20 beginning on or after January 1, 2017, for persons receiving uncovered civil
21 service retirement plan benefits, "pension deduction amount" means the
22 maximum annual benefit that an individual retiring at age 66 during January
23 of the tax year may receive under the federal Social Security Act.

24 (e) "Primary recipient" means the individual upon whose earnings or
25 contributions the retirement plan benefits are based or the surviving spouse of
26 that individual.

27 (f) "Retirement plan benefits" means employee retirement plan benefits,
28 except pick-up contributions for which a subtraction is allowed under
29 paragraph E, reported as pension or annuity income for federal income tax
30 purposes and individual retirement account benefits reported as individual
31 retirement account distributions for federal income tax purposes.
32 "Retirement plan benefits" does not include distributions that are subject to
33 the tax imposed by the Code, Section 72(t);.

34 (g) "Uncovered civil service retirement plan benefits" means employee
35 retirement plan benefits received under Title 5, Part 20 or under a similar
36 retirement plan of another state government, a local government or the
37 Federal Government, as a result of service that is considered noncovered
38 service under 42 United States Code, Section 415(a)(7)(A)(ii);'

39 **SUMMARY**

40 This amendment, which is the majority report, provides that the maximum income
41 tax deduction for a retired individual receiving retirement benefits under a retirement plan

1 based on employment compensation for which contributions are not made to the federal
2 social security system is equal to the maximum annual social security benefit that may be
3 received by a person retiring at 66 years of age in January of the applicable year.
