Amend the bill in section 1 in subsection 4 in paragraph A in the last line (page 1, line 9 in L.D.) by inserting after the following: "reported" the following: 'and a medical creditor, debt collector or debt buyer may not report a consumer's medical debt to a consumer reporting agency'

5 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section 6 number to read consecutively.

SUMMARY

8 This amendment prohibits the reporting of medical debt on a consumer report and 9 clarifies that medical debt has the same definition as currently used in the Maine Fair Debt 10 Collection Practices Act. The amendment also prohibits a debt collector, debt buyer or an 11 entity that provides health care services from reporting medical debt to a consumer 12 reporting agency.
