6 7 8	1. The State's need for and intended use of oral fluid testing, including whether oral fluid testing will be used to assist in establishing probable cause or whether it will be used for evidentiary purposes, or both;
9 10	2. Legal and regulatory changes required to allow the use of oral fluid testing in the State;

How the use of oral fluid testing may impact administrative license suspensions, including whether refusal to submit to oral fluid testing should result in an administrative license suspension and whether the results of oral fluid testing can be used as a basis for an administrative license suspension;

27 28 29 30 31 32	This amendment replaces the bill with a resolve. The amendment directs the Department of Public Safety, Bureau of Highway Safety to convene a working group to study the use of oral fluid testing to determine the intoxication of drivers, aircraft operators and hunters. The bureau is required to submit a report by January 1, 2026 to the Joint Standing Committee on Criminal Justice and Public Safety. The committee may submit legislation based on the report to the Second Regular Session of the 132nd Legislature.
