It includes statutory references to defined terms used in the definition of "ranked-choice voting." It replaces the 13 14 term "count" with the term "tabulate" when referring to the process of determining the number of votes cast for a candidate in each round of an election determined by 15 16 ranked-choice voting. It also clarifies that in the definition of "ranking" the preference 17 being demonstrated by the voter for a candidate is relative to other candidates for the same office on that ballot. 18
