COMMITTEE AMENDMENT “ ” to S.P. 686, L.D. 1984, Bill, “An Act To Eliminate Waiting Lists for Home and Community-based Services for Adults with Intellectual Disabilities, Autism, Brain Injury and Other Related Conditions”

Amend the bill by striking out the title and substituting the following:

'An Act To Eliminate Waiting Lists for Support Services for Adults with Intellectual Disabilities or Autism and Reduce Waiting Lists for Home and Community-based Services for Adults with Intellectual Disabilities or Autism'

Amend the bill by striking out everything after the title and inserting the following:

'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, persons with disabilities have the right to dignity and to receive the support they need to work and to be otherwise included in their communities; and

Whereas, many persons with disabilities have an urgent need for adult home and community-based services to provide support and to enable their family members to work; and

Whereas, as of December 2019, more than 180 persons on the waiting list for services under the MaineCare Benefits Manual, Chapters II and III, Section 21 were receiving no services at all; and

Whereas, providing and increasing services for all MaineCare members eligible for services under the MaineCare Benefits Manual, Chapters II and III, Section 29 protects their dignity and ensures their safety; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine as follows:

12 **SUMMARY**

13 This amendment replaces the bill and provides funding to:

- 14 1. Clear the waiting list for services under the MaineCare Benefits Manual, Chapters
15 II and III, Section 29 through the end of fiscal year 2020-21;
- 16 2. Increase the annual cap for a person receiving services under the MaineCare
17 Benefits Manual, Chapters II and III, Section 29 to \$70,000; and
- 18 3. Reduce waiting lists for services under the MaineCare Benefits Manual, Chapters
19 II and III, Section 21 by providing services to those individuals who are designated
20 Priority 2 and are receiving no other MaineCare home and community-based or support
21 services.
