COMMITTEE AMENDMENT “ ” to S.P. 714, L.D. 1871, Bill, “An Act To Implement the Recommendations of the Task Force To Address the Opioid Crisis in the State Regarding Respectful Language”

Amend the bill by striking out all of the emergency preamble.

Amend the bill in Part A in section 1 in §125 in the first paragraph in the 3rd line (page 1, line 26 in L.D.) by striking out the following: "alcoholism" and inserting the following: '~~alcoholism~~ appropriate'

Amend the bill in Part A by striking out all of section 5 and inserting the following:

**'Sec. A-5. 5 MRSA §957, sub-§1,** as enacted by PL 1989, c. 857, §19, is amended to read:

**1. Assessment and referral.** The program shall provide assessment and referral services to employees whose work performance has been affected by behavioral or medical disorders including, but not limited to, ~~alcoholism and drug abuse~~ substance use disorder, misuse of ~~other~~ drugs, emotional problems, family disorders and financial, legal, marital and any other stresses. The major elements of the program consist of the following:

- A. An assessment interview;
- B. Referral to appropriate treatment;
- C. Follow-up;
- D. Coordination of a benefit package;
- E. Continuous care;
- F. Maintenance of confidentiality of client records; and
- G. Education of state employees.'

Amend the bill in Part A in section 6 by striking out all of subsection 6 (page 4, lines 14 to 20 in L.D.) and inserting the following:

**COMMITTEE AMENDMENT**

1           **6. Social service.** "Social service" means any children's, youth, adult or elderly  
2 service and ~~alcoholism~~ substance use disorder, community action, developmental  
3 disability, ~~drug or substance abuse~~, home-heating assistance, juvenile, mental health,  
4 intellectual disability, older Americans, poverty, rehabilitation, transportation,  
5 weatherization or other social service that may be defined in the future and that is  
6 operated by the departments or the division utilizing state-administered funds, including  
7 related health and medical services and income supplementation programs.'

8           Amend the bill in Part A by inserting after section 12 the following:

9           '**Sec. A-13. 5 MRSA §20003, sub-§1**, as amended by PL 1991, c. 601, §3, is  
10 repealed.'

11           Amend the bill in Part A by inserting after section 17 the following:

14           Amend the bill in Part A in section 18 by striking out all of subsection 17-A (page 6,  
15 lines 19 to 22 in L.D.) and inserting the following:

16           '**17-A. Person with substance use disorder.** "Person with substance use disorder"  
17 means a person who, due to the use of alcohol or a drug, has a clinical and significant  
18 functional impairment, including a health problem or a disability or an inability to meet  
19 major responsibilities at work, home or school. A substance use disorder may be mild,  
20 moderate or severe as determined by the diagnostic criteria met by the person.'

21           Amend the bill in Part A by striking out all of sections 20 to 22 and inserting the  
22 following:

23           '**Sec. A-20. 5 MRSA §20003, sub-§21**, as enacted by PL 1989, c. 934, Pt. A, §3,  
24 is repealed.

26           '**21-A. Substance use prevention.** "Substance use prevention" means all facilities,  
27 programs or services relating to substance use control, education, rehabilitation, research,  
28 training and treatment, including reinforcing health behaviors and lifestyles and reducing  
29 risks contributing to alcohol, tobacco and other drug misuse. "Substance use prevention"  
30 does not include any function defined in subsection 19 as "prevention of drug traffic."

31           **Sec. A-22. 5 MRSA §20003, sub-§22**, as enacted by PL 1989, c. 934, Pt. A, §3,  
32 is amended to read:

33           **22. Treatment.** "Treatment" means the broad range of emergency, outpatient,  
34 intermediate and inpatient services and care, including career counseling, diagnostic  
35 evaluation, employment, health, medical, psychiatric, psychological, recreational,  
36 rehabilitative, social service care, treatment and vocational services, that may be extended  
37 to ~~an alcoholic, intoxicated person, a drug abuser user, drug addict, drug-dependent a~~  
38 person with substance use disorder or a person in need of assistance due to the use of a  
39 dependency-related drug.'

40           Amend the bill in Part A in section 23 in §20005 by striking out all of subsection  
41 12-A (page 10, lines 4 to 8 in L.D.) and inserting the following:

1           **'12-A. Training programs.** Provide or assist in the provision of training programs  
2 for all persons in the field of treating ~~alcoholics and drug abusers~~ persons with substance  
3 use disorder, persons engaged in the prevention of ~~alcohol and other drug abuse~~ substance  
4 use disorder or any other organization or individual in need of or requesting training or  
5 other educational information related to ~~alcohol or other drug abuse~~ substance use  
6 disorder.'

7           Amend the bill in Part A in section 29 in §20008 by striking out all of subsection 3  
8 (page 12, lines 7 to 10 in L.D.) and inserting the following:

9           **'3. Treatment.** The department shall provide for adequate and appropriate treatment  
10 for ~~alcoholics, drug abusers~~ users, drug addicts persons with substance use disorder and  
11 ~~drug-dependent~~ persons admitted under sections 20043 ~~to~~ and 20044. Treatment may not  
12 be provided at a correctional institution, except for inmates.'

13           Amend the bill in Part A in section 32 in §20022 by striking out all of subsection 1  
14 (page 13, lines 15 to 17 in L.D.) and inserting the following:

15           **'1. Research.** Conducting research on the causes and nature of drugs, ~~drug abuse~~  
16 substance use or people who are dependent on drugs, ~~especially alcoholics and~~  
17 ~~intoxicated persons~~ or alcohol.'

18           Amend the bill in Part A in section 32 in §20022 by striking out all of subsection 4

20           **'4. Treatment facilities.** Maintaining an inventory of the types and quantity of ~~drug~~

22 under public or private auspices to ~~drug addicts, persons with substance use disorder and~~  
23 ~~drug abusers and drug-dependent persons, especially alcoholics and intoxicated persons~~  
24 users. This function includes the unduplicated count, locations and characteristics of  
25 persons receiving treatment, as well as the frequency of admission and readmission and  
26 the frequency and duration of treatment of those persons. The inventory must include the  
27 amount, type and source of resources for ~~drug abuse~~ substance use disorder prevention.'

28           Amend the bill in Part A by striking out all of section 33 (page 13, lines 31 to 40 and  
29 page 14, lines 1 and 2 in L.D.) and inserting the following:

30           **'Sec. A-33. 5 MRSA §20023, first ¶,** as amended by PL 2011, c. 657, Pt. AA,  
31 §32, is further amended to read:

32           To the fullest extent possible, the Commissioner of Education shall coordinate all  
33 elementary and secondary school ~~alcohol and drug abuse~~ substance use disorder  
34 education programs administered by the Department of Education and funded under the  
35 federal Drug-Free Schools and Communities Act of 1986 with programs administered by  
36 the Department of Health and Human Services. The Commissioner of Education shall  
37 participate in planning, budgeting and evaluation of ~~alcohol and other drug abuse~~  
38 substance use disorder programs, ~~in cooperation with the Substance Abuse Advisory~~  
39 ~~Group~~, and ensure that ~~alcohol and drug abuse~~ substance use disorder education programs  
40 administered by the Department of Education that involve any community participation  
41 are coordinated with available treatment services.'

5 'The department shall adopt rules for acceptance of persons into a treatment program,  
6 considering available treatment resources and facilities, for the purpose of early and  
7 effective treatment of ~~alcoholics, drug abusers, drug addicts and drug-dependent persons~~  
8 users and persons with substance use disorder.'

9 Amend the bill in Part A in section 36 in §20044 in the first 2 lines (page 15, lines 26  
10 and 27 in L.D.) by striking out the following: "**alcoholics, drug users, persons with**  
11 **substance use disorder and drug-dependent persons"** and inserting the following:  
12 **'drug users and persons with substance use disorder'**

13 Amend the bill in Part A in section 36 in §20044 by striking out all of subsection 1  
14 (page 15, lines 28 to 30 in L.D.) and inserting the following:

15 **'1. Voluntary treatment.** ~~An alcoholic, drug abuser, drug addict or drug-dependent~~  
16 ~~person~~ A drug user or person with substance use disorder may apply for voluntary  
17 treatment directly to an approved treatment facility.'

18 Amend the bill in Part A by inserting after section 37 the following:

19 **'Sec. A-38. 5 MRSA §20051, sub-§1,** as amended by PL 2009, c. 299, Pt. A, §1,  
20 is further amended to read:

21 **1. Laws.** A county, municipality or other political subdivision may not adopt or  
22 enforce a local law, ordinance, regulation or rule having the force of law that includes  
23 drinking, ~~being a person with alcoholism~~ or being found in an intoxicated condition as  
24 one of the elements of an offense giving rise to a criminal or civil penalty or sanction.'

25 Amend the bill in Part A in section 40 in subsection 3 in paragraph J by striking out  
26 all of subparagraph (5) (page 17, lines 23 to 25 in L.D.) and inserting the following:

27 '(5) Persons ~~affected by or recovering from alcoholism, chronic intoxication,~~  
28 ~~drug abuse or drug dependency, evidenced by~~ in recovery from substance use  
29 disorder for a minimum of 3 years ~~of sobriety or abstinence from drug abuse.'~~

30 Amend the bill in Part A in section 41 in §20067 in subsection 2 in the last line (page

35 **'3. Serve as advocate; review and evaluate; inform the public.** The commission  
36 shall serve as an advocate on ~~alcoholism and drug abuse~~ substance use disorder  
37 prevention, promoting and assisting activities designed to meet the problems of ~~drug~~  
38 ~~abuse and drug dependence~~ substance use disorder at the national and state levels. With  
39 the support of the department, the commission shall review and evaluate on a continuing

30 The department shall adopt rules to implement this section. Rules adopted pursuant to  
31 this section are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.  
32 Prior to adopting rules under this section, the department shall seek input from  
33 stakeholders and experts in the field of substance ~~abuse addiction and recovery use~~  
34 disorder, including, but not limited to, representatives of the ~~Office of Substance Abuse~~

34 section and the total amount of claims paid in this State for group health care contracts,  
35 both separated between those paid for inpatient and outpatient services. The

24 written notification to all individuals eligible for benefits under group policies or  
25 contracts of ~~these alcoholism and drug dependency~~ substance use disorder benefits.

26           **8. Confidentiality.** ~~Alcoholism and drug~~ Substance use disorder treatment patient  
27 records are confidential.

28           **9. Reports to the Superintendent of Insurance.** Every insurer subject to this  
29 section shall report its experience for each calendar year beginning with 1984 to the  
30 superintendent not later than April 30th of the following year. The report ~~shall~~ must be in  
31 a form prescribed by the superintendent and ~~shall~~ must include the amount of claims paid  
32 in this State for the services required by this section and the total amount of claims paid  
33 in this State for group health care contracts, both separated between those paid for  
34 inpatient and outpatient services. The superintendent shall compile this data for all  
35 insurers in an annual report.

36           **10. Application; expiration.** The requirements of this section ~~shall~~ apply to all  
37 policies and any certificates or contracts executed, delivered, issued for delivery,  
38 continued or renewed in this State on or after January 1, 1984. For purposes of this  
39 section, all contracts ~~shall be~~ are deemed to be renewed no later than the next yearly  
40 anniversary of the contract date.'

6 prescribed by section 2748, subsection 3 and section 2840-A, subsection 3; and for breast  
7 cancer screening services in the format prescribed by section 2745-A, subsection 4 and  
8 section 2837-A, subsection 4 applies to health maintenance organizations.'

9           Amend the bill in Part A by inserting after section 98 the following:

10           **'Sec. A-99. 25 MRSA §2002, sub-§5**, as amended by PL 1993, c. 524, §1, is  
11 repealed.'

12           Amend the bill in Part A in section 99 in paragraph D in subparagraph (5) by striking  
13 out all of division (r) (page 40, lines 9 and 10 in L.D.) and inserting the following:

14                   '(r) Are you a drug abuser, ~~drug addict or drug dependent person~~ user or a  
15 person with substance use disorder?'

16           Amend the bill in Part A by inserting after section 112 the following:

17           **'Sec. A-113. 28-A MRSA §2519, sub-§3, ¶B**, as enacted by PL 1987, c. 45, Pt.  
18 A, §4, is amended to read:

19           B. The course provides instruction and the development of skills in the following  
20 subject matters:

21                   (1) Identification of intoxicated individuals and minors;

22                   (2) Intervention to prevent excessive consumption of alcohol by such methods as  
23 serving food and encouraging the consumption of nonalcoholic beverages;

24                   (3) Making consumers aware of their condition and their responsibility for  
25 driving in an intoxicated condition and providing alternate transportation when  
26 available;

27                   (4) Knowledge of state laws relating to the sale and distribution of alcohol and  
28 the legal responsibilities of servers and consumers;

29                   (5) Knowledge of the effect of alcohol by volume and timing of intake in

2 §2, is amended to read:

3       **1. Agency.** "Agency" means an establishment, organization or institution, public or  
4 private, that is licensed by the Department of Health and Human Services and that offers,  
5 purports to offer, maintains or operates one or more programs for the assessment,  
6 diagnosis, care, treatment or rehabilitation of individuals who are suffering physically,  
7 emotionally or psychologically from ~~the abuse of alcohol or other drugs~~ substance use  
8 disorder.'

9       Amend the bill in Part A by striking out all of section 130 (page 64, lines 25 to 29 in  
10 L.D.) and inserting the following:

11       '**Sec. A-130. 32 MRSA §6203-A, sub-§7**, as enacted by PL 2007, c. 402, Pt. U,  
12 §2, is amended to read:

13       **7. Consumer of alcohol and drug counseling services.** "Consumer of alcohol and  
14 drug counseling services" means a person affected by or recovering from ~~alcoholism or~~  
15 ~~other drug abuse~~ substance use disorder.'

16       Amend the bill in Part A in section 138 in paragraph F in subparagraph (5) by  
17 striking out all of division (h) (page 67, lines 10 and 11 in L.D.) and inserting the  
18 following:

19               '(h) Are you a drug ~~abuser, drug addict or drug-dependent person~~ user or a  
20 person with substance use disorder?'

21       Amend the bill in Part A by striking out all of section 139 (page 67, lines 34 to 37 in  
22 L.D.) and inserting the following:

23       '**Sec. A-139. 32 MRSA §9410-A, sub-§1, ¶H**, as enacted by PL 1987, c. 170,  
24 §12, is amended to read:

25               H. Is not a drug ~~abuser, drug addict or drug-dependent person~~ user or a person with  
26 substance use disorder;'

27       Amend the bill in Part A in section 152 in paragraph D in the first line (page 70, line  
28 26 in L.D.) by striking out the following: "alcoholism," and inserting the following:  
29 '~~alcoholism,~~'

30       Amend the bill in Part A by striking out all of section 158 (page 72, lines 5 to 21 in  
31 L.D.).

32       Amend the bill in Part B by striking out all of section 1 and inserting the following:

33       '**Sec. B-1. Executive branch rules, forms, policies and publications.** On or  
34 after the effective date of this section, when adopting or amending rules and developing  
35 or publishing forms, policies and publications, all executive branch entities shall replace  
36 references to "substance abuse" with references to "substance use disorder" and shall  
37 ensure that language referring to persons with substance use disorder is consistent with  
38 respectful, "person first," language.'

39       Amend the bill by striking out all of the emergency clause.

1 Amend the bill by relettering or renumbering any nonconsecutive Part letter or  
2 section number to read consecutively.

3 **SUMMARY**

4 This amendment removes statutory references to "alcoholic" and "alcoholism" as  
5 "substance use disorder" includes both alcohol and drug dependence. It also removes  
6 statutory references to "drug-dependent person" as this term is included in the term  
7 "person with a substance use disorder." It changes the definition of "person with  
8 substance use disorder" that is in the bill to a definition similar to that used in the clinical  
9 setting. It also removes provisions from the bill that rename the Office of Substance  
10 Abuse and Mental Health in the Department of Health and Human Services. The  
11 amendment requires that all executive agencies, rather than only the Department of  
12 Health and Human Services, replace references to "substance abuse" with "substance use  
13 disorder" in rules, forms, policies and publications and specifies that those changes must  
14 occur as agencies amend or create those documents. The amendment also removes the  
15 emergency preamble and emergency clause.
