4 5 6	B. An eligible recipient of cash assistance from the TANF program who knowingly makes a prohibited purchase in violation of paragraph A is subject to the following penalties:

9 10	(2) For a 2nd offense, a period of disqualification for benefits that does not exceed one year;

21 22 23 24 25 26 27 28	Sec. 5. Department of Health and Human Services to educate recipients of the Temporary Assistance for Needy Families program. The Department of Health and Human Services shall develop an education program for recipients of benefits under the Temporary Assistance for Needy Families program, referred to in this section as "TANF," that emphasizes that those benefits under TANF are to be used for supporting dependent children. The program must educate TANF recipients regarding the agreement entered into by the recipient pursuant to the Maine Revised Statutes, Title 22, section 3763, subsection 12, including but not limited to:
29	1. Appropriate, approved and specific uses of TANF benefits;

Refraining from using the electronic benefits transfer system to pay for tobacco products, liquor products, gambling activities, lotteries or bail, including refraining from using the electronic benefits transfer system at automated teller machines to withdraw TANF benefits as cash, which is then used to pay for those products or activities; and
34 35 36	3. The prohibition on using the electronic benefits transfer system for transactions for unauthorized spending pursuant to the Maine Revised Statutes, Title 22, section 23 and section 3763, subsection 11.
37 38 39	Sec. 6. Department of Health and Human Services to collect information on purchases of certain items. The Department of Health and Human Services shall collect information on the costs and impact of implementing and enforcing the

1 2	prohibitions set forth in the Maine Revised Statutes, Title 22, section 3763, subsection 11, including the:
3	1. Administrative costs of implementation and costs of enforcing the prohibitions;
4 5	2. Number of recipients who have been finally determined by the department to have violated the prohibitions;
6 7	3. Status of and final adjudication of any judicial appeals of determinations by the department;
8 9 10	4. Number of individuals who have been penalized under Title 22, section 3763, subsection 11, paragraph B, segregated by the categories of penalty described in that paragraph; and

17	SUMMARY
18 19	This amendment incorporates the substance of Senate Amendment "A" to Committee Amendment "A" (S-505), except that it changes the penalties to:
20	1. For a first offense, a disqualification for benefits of no more than 15 days;
21	2. For a 2nd offense, a disqualification for benefits of no more than one year;
22	3. For a 3rd offense, a disqualification for benefits of no more than 3 years; and
23 24	4. For a 4th and subsequent offense, a disqualification for benefits for the lifetime of the recipient.
25 26 27 28	Like Senate Amendment "A" to Committee Amendment "A," this amendment prohibits recipients of TANF benefits from expending TANF benefits on, and retailers and vendors from accepting TANF benefits through EBT debit cards for, tobacco, liquor and imitation liquor, gambling, lotteries and bail.
