23 24	<u>A.</u> Primary elections for the offices of United States Senator, United States Representative to Congress, Governor, State Senator and State Representative;

1 Sec. 2. 21-A MRSA §601, sub-§2, ¶J, as enacted by IB 2015, c. 3, §3, is 2 amended to read:

- J. For offices elected elections determined by ranked-choice voting, the ballot must be simple and easy to understand and allow a voter to rank candidates for an office in order of preference. A voter may include no more than one write-in candidate among that voter's ranked choices for each office.
- Sec. 3. 21-A MRSA §695, first ¶, as amended by PL 2001, c. 516, §10, is further

9 Except for elections determined by ranked-choice voting, the following provisions apply to the counting of ballots. The election clerks shall count the ballots under the 10 supervision of the warden as soon as the polls are closed, except that if, in the opinion of 11 the municipal clerk the public interests will best be served, referendum ballots may be 12 13 counted on the day immediately following the election, as long as the count is completed within 24 hours after the polls are closed. Tabulation must proceed in rounds. In each round, the number of 9 votes for each continuing candidate must be counted. Each continuing ballot counts as 10 one vote for its highest-ranked continuing candidate for that round. Exhausted ballots are 11 not counted for any continuing candidate. The round then ends with one of the following 12 2 potential outcomes.

- A. If there are 2 or fewer continuing candidates, the candidate with the most votes is
 declared the winner of the election.
- B. If there are more than 2 continuing candidates, the last-place candidate is defeatedand a new round begins.

15 16	This amendment requires the Secretary of State to adopt routine technical rules for the administration of ranked-choice voting, including the administration of recounts.		
17 18	This amendment also provides funding to the Secretary of State and the Department of Public Safety to implement ranked-choice voting.
