The amendment repeals 2 conflicting versions of the Maine Revised Statutes, Title 17-A, section 1107-A, 3 subsection 1, paragraph B, which was amended by Public Law 2015, chapter 308, section 4 5 2 and chapter 346, section 6. The amendment resolves the conflict and enacts a new version of Title 17-A, section 1107-A, subsection 1, paragraph B. 6 Under this amendment, and subject to other provisions of law that address the quantities of drugs 7 8 possessed: 9 The first offense of possession of heroin, methamphetamine, oxycodone, 1. 10 hydrocodone, hydromorphone or fentanyl powder, or cocaine in the form of cocaine base if the quantity possessed is 2 grams or more, is a Class D crime; 11 12 2. The 2nd and subsequent offenses of possession of heroin, methamphetamine, 13 oxycodone, hydrocodone, hydromorphone or fentanyl powder, or cocaine in the form of cocaine base if the quantity possessed is 2 grams or more, is a Class C crime; 14 15 3. The first offense and the 2nd and subsequent offenses of possession of cocaine in 16 the form of cocaine base if the quantity possessed is less than 2 grams is a Class D crime; 17 and 18 4.
