Amend the amendment in Part J in subsection 5-C in the 4th line (page 576, line 31 in amendment) by striking out the following: "\$85,949,391" and inserting the following: '\$83,964,862'

Amend the amendment by inserting after Part MMMMM the following:

'PART NNNNN

Sec. NNNNN-1. Appropriations and allocations. The following appropriations and allocations are made.

Initiative: Deappropriates and deallocates funds due to the elimination of MaineCare reimbursement for transportation services to and from methadone treatment for addiction to opioids.
