13 **SUMMARY**

14 This amendment adds a provision requiring carriers to provide written notice  
15 regarding the requirements for inpatient coverage following treatment of breast cancer to  
16 physicians participating in the carrier's provider network and requiring attending  
17 physicians to provide a similar notice to patients when consulting with patients about  
18 breast cancer treatment.
