**'Sec. 2. Report. Resolved:** That, by December 1, 2027, the Permanent Commission on the Status of Women shall submit a report based on its findings in section 1 to the Secretary of State and the joint standing committee of the Legislature having jurisdiction over labor matters, which may report out legislation regarding the report to the Second Regular Session of the 133rd Legislature.'

Amend the amendment by striking out all of section 3 and inserting the following:

**'Sec. 3. Appropriations and allocations. Resolved:** That the following appropriations and allocations are made.
