This amendment 27 repeals the pesticide container fee on May 1, 2017. The Commissioner of Agriculture, 28 Conservation and Forestry is given administrative control over the Animal and Plant 29 Disease and Insect Control Fund after that date and provided the authority to disburse the 30
