SENATE AMENDMENT “ ” to COMMITTEE AMENDMENT “A” to H.P. 815, L.D. 1150, Bill, “An Act To Require Prevailing Wages To Be Paid on All Public Works Projects Receiving State Funding”

Amend the amendment by striking out everything after the title and before the summary and inserting the following:

'Amend the bill by striking out the title and substituting the following:

'An Act To Continue Certain Position Distributions in the Department of Labor and To Amend the Competitive Skills Scholarship Program'

Amend the bill by striking out everything after the title and before the summary and inserting the following:

Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the proposed position changes and funding represent continuity with the current fiscal year; and

Whereas, the continuity is essential for the proper provision of the services to be funded; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 26 MRSA §2033, sub-§2, as enacted by PL 2007, c. 352, Pt. A, §3, is amended to read:

2. Program established. The department shall establish and administer an employment training program known as the Competitive Skills Scholarship Program. The purpose of the program is to provide individuals with access to education, training and support leading to skilled, well-compensated jobs with anticipated high employment demand, to improve the economic well-being of the participants in the program and to

1 provide employers with a skilled labor force in accordance with the provisions of this
 2 section.

3 The commissioner may expend funds through the department's career centers from the
 4 fund for the costs of education, training and support in accordance with subsection 6, for
 5 career counseling and for the administration of the program. Career counseling must
 6 include developing a plan and assisting a participant in accessing the support necessary
 7 for the participant to participate in the plan. The commissioner shall establish a limit on
 8 or a formula that limits the proportion of program funds that are expended on career
 9 counseling and for administration; except that, beginning with fiscal year 2014-2015, the
 10 commissioner may not expend, on an annualized basis, more than 10% of the annual
 11 revenue to the fund for administrative costs and for career counseling.

12 **Sec. 2. 26 MRSA §2033, sub-§11** is enacted to read:

13 **11. Enrollment of eligible supplemental nutrition assistance program**
 14 **participants.** The department shall enroll, to the maximum extent possible and when
 15 appropriate, participants in the federal supplemental nutrition assistance program
 16 administered by the State pursuant to Title 22, section 3104 who meet the eligibility
 17 criteria specified in subsection 5 and who are referred to the program pursuant to a
 18 memorandum of agreement entered into by the State with the Department of Health and
 19 Human Services as part of the individual’s self-sufficiency plan under the federal
 20 supplemental nutrition assistance program administered by the State pursuant to Title 22,
 21 section 3104. Federal funds may not be used to supplant state funds used to provide
 22 education, training and support under this section to program participants enrolled
 23 pursuant to this subsection.
