The department may assist in the transfer to ensure that the permit holders meet the requirements of section 10756, but the State bears no responsibility for enforcing the terms of the exchange between the permit holders. The commissioner may adopt rules to implement this section. Rules adopted pursuant to this section are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

Notwithstanding subsection 1, the holder of a moose permit who has been assigned a designated hunting area, zone or season by the department may not exchange that designated zone, area or season with another person assigned a different hunting zone, area or season for any consideration other than the other person's different hunting zone, area or season. A person who violates this subsection commits a Class D crime.

are exchanging those permits pursuant to subsection 1. A person who violates this
subsection commits a Class E crime.'

## **SUMMARY**

4 This amendment replaces the bill. The bill repeals the prohibition on transferring a 5 moose permit for consideration and directs the Department of Inland Fisheries and Wildlife to establish an online transfer system for permits. The amendment removes the 6 provision of the bill that directs the department to establish an online transfer system for 7 8 permits, but, like the bill, the amendment repeals the prohibition on transferring moose permits for consideration. This amendment prohibits persons other than the holders of 9 moose permits who are exchanging hunting zones, areas or seasons to facilitate the 10 11 exchange for any consideration. The amendment establishes that a person who facilitates an exchange of moose permits commits a Class E crime. The amendment clarifies that the 12 13 State bears no responsibility for enforcing the terms of an exchange between the permit 14 holders. 15 FISCAL NOTE REQUIRED
