SUMMARY

15 This amendment makes the following changes to the bill.

16 1. It increases the application and renewal fees for a concealed handgun permit from 17 \$35 to \$52.50 and from \$20 to \$52.50, respectively, for a resident. For a nonresident the 18 fee is increased from \$60 to \$120 for either an application or a renewal.

192. The bill proposes to extend the period a permit is valid from 4 to 10 years. This20 amendment makes a permit valid for 5 years.

3. It requires the State Police to establish a centralized database containing information about concealed handgun permit holders and applicants for concealed handgun permits. It provides that the centralized database must be accessible by law enforcement agencies or law enforcement officers or by court order and that information about a permit holder or an applicant must be purged from the centralized database within 5 years after the permit expires or after the period for an appeal of a denial or a revocation of a permit has run.

4. It provides that an application for a concealed handgun permit received before January 1, 2017 is not subject to the provisions of this legislation, but an application for a new concealed handgun permit or a renewal of a concealed handgun permit received by an issuing authority on or after January 1, 2017 is subject to this legislation.
