Sec. 2. Review committee membership. Resolved: That, notwithstanding 1 Joint Rule 353, the review committee consists of 15 members appointed as follows: 2 1. Two members of the Senate appointed by the President of the Senate, including 3 one member from each of the 2 parties holding the largest number of seats in the 4 Legislature; 5 2. Three members of the House of Representatives appointed by the Speaker of the 6 House of Representatives, including at least one member from each of the 2 parties 7 holding the largest number of seats in the Legislature; 8 9 3. The Attorney General or the Attorney General's designee; 10 4. The Commissioner of Public Safety or the commissioner's designee; 5. Emergency clause. In view of the emergency cited in the preamble, this legislation takes effect when approved.'

SUMMARY

9 This amendment strikes the bill and replaces it with a resolve that establishes the 10 Criminal Records Review Committee, consisting of 15 members, including a member 11 representing the judicial branch if one is designated by the Chief Justice of the Supreme 12 Judicial Court.

The review committee is directed to look at all issues concerning limiting public availability of criminal records and to provide recommendations to the Joint Standing Committee on Judiciary by December 4, 2019. The review committee's funding must come from outside sources. The amendment also adds an appropriations and allocations section.
