The Secretary of State shall make the person's petition for relicensure known to the family of any victims of the person's offense and shall consider the family's testimony in determining whether to reissue the person a driver's license.'

The amendment grants the Secretary of State discretionary authority to reissue a license to a person 8 years instead of 10 years after the date the person is no longer incarcerated when the person's license is revoked as a result of that person's operation of a motor vehicle having caused the death of another person when the person operating the motor vehicle was under the influence of intoxicants at the time of the offense.
