Resolve, to Increase the Availability of Community Children's Behavioral Health Services by Providing Training and Career Opportunities for Behavioral Health Professionals

1 Sec. 1. Department of Health and Human Services to develop course 2 curriculum, credential and career path for behavioral health professionals serving children in the community. Resolved: That the Department of Health and 3 4 Human Services, Office of MaineCare Services and Office of Child and Family Services 5 shall coordinate in the development of a course curriculum, credential and career path for behavioral health professionals. The course curriculum must be offered through 6 7 community college courses around the State or by a contracted agency with multiple sites 8 around the State. Individuals participating in the course curriculum must have a high school diploma or equivalent and a driver's license. The course curriculum must lead to a 9 credential that is sufficient to satisfy department licensing requirements for any behavioral 10 health professional providing services to children in the community. The department shall 11 also coordinate the development of a career path for behavioral health professionals serving 12 13 children in the community. The career path must allow for individuals who have met the 14 course curriculum requirements with a corresponding credential that is portable across behavioral health fields. 15

Sec. 2. Incentives. Resolved: That the Department of Health and Human Services
shall explore options for providing incentives to individuals wishing to pursue the course
curriculum developed pursuant to section 1, including but not limited to grants or free or
reduced tuition.

Sec. 3. Weekly supervision requirements. Resolved: That, no later than
January 1, 2024, the Department of Health and Human Services shall require that all
behavioral health professionals receive no less than one hour per week of supervision by a
licensed clinician. The supervision may be in a group or individual setting.

24 Sec. 4. MaineCare rates for behavioral health professionals serving children in the community. Resolved: That the Department of Health and Human 25 Services shall amend its rules in Chapter 101: MaineCare Benefits Manual, Section 28, 26 Rehabilitative and Community Support Services for Children with Cognitive Impairments 27 and Functional Limitations, and Section 65, Behavioral Health Services, to increase 28 29 MaineCare rates for services provided by behavioral health professionals to children in the community. Rate increases must apply only to those behavioral health professionals who 30 have completed the course curriculum requirements and received the credential pursuant 31 32 to section 1 to allow for a livable wage to be earned by the behavioral health professional. 33 The department shall increase the rates to take effect as new behavioral health professionals 34 complete the course curriculum and credential requirements. Rules adopted pursuant to 35 this section are routine technical rules as defined in the Maine Revised Statutes, Title 5, 36 chapter 375, subchapter 2-A.

SUMMARY

This resolve requires the Department of Health and Human Services, Office of MaineCare Services and Office of Child and Family Services to coordinate the development of a course curriculum, credential and career path for behavioral health professionals providing services to children in the community. The course curriculum must be offered through community college courses around the State or by a contracted agency with multiple sites around the State. The course curriculum must lead to a credential that is portable and sufficient to satisfy department licensing requirements for any behavioral health professional serving children in the community. The department shall explore options for providing incentives to individuals wishing to pursue the course curriculum, including but not limited to grants or free or reduced tuition. The resolve also requires MaineCare program rates to be increased for services provided by behavioral health professionals with the training. The resolve requires that all behavioral health professionals providing services to children in the community receive one hour per week of clinical supervision.
