A member of the council appointed pursuant to subsection 2, paragraph B serves for a term of 3 years. Terms must be staggered so that 4 approximately one-third 1/3 of the council is renewed each calendar year. If a member is 5 unable to complete the term, the commissioner shall appoint a member from the same 6 7 category of members listed in subsection 2, paragraph B as the member who vacated the council to serve out the unexpired portion of the term. 1 SUMMARY 2 This amendment does the following. 3 1. It specifies that the Department of Transportation's duty to facilitate and support the public transportation systems in the State to achieve accessibility, affordability and 4 5 convenience is for the average person's mobility needs. 6 2. It removes from the bill the requirement to reduce greenhouse gas emissions in 7 accordance with emissions reduction targets. 8 3. It changes the membership of the Public Transit Advisory Council. 9 4. It removes the requirement that the Commissioner of Transportation determine how 10 the council chooses a chair and for how long the chair serves. It removes from the bill that 11 the council is allowed to establish a steering committee. The amendment requires the council to annually elect a chair and vice chair from among its members and provides that 12 they serve a term of one year. 13 14 5. It requires the council to meet 3 times a year instead of 4 times a year, as in the bill, 15 and allows the council to create subcommittees and adopt bylaws and other policies to 16 effectively govern the council's proceedings. 6. It changes the council's report provided each year to include an assessment of the 17 18 infrastructure provided in each geographic region. It adds that the report must include recommendations for supporting infrastructure that should be provided and an estimate of 19 20 the cost of providing that infrastructure and a recommendation for including additional 21 funding as needed. It removes from the bill the requirement that the report include a 22 progress report on the implementation of the statewide mobility management program. It 23 removes from the bill the authority to report out a bill by the joint standing committees of the Legislature having jurisdiction over transportation matters and health and human 24 25 services matters. 26 7.
