COMMITTEE AMENDMENT

1 **Sec. 2.** Application. This Act applies to all policies, contracts and certificates 2 executed, delivered, issued for delivery, continued or renewed in this State on or after 3 January 1, 2022. For purposes of this Act, all contracts are deemed to be renewed no later 4 than the next yearly anniversary of the contract date.

5 **Sec. 3.** Exemption from review. Notwithstanding the Maine Revised Statutes, Title 6 24-A, section 2752, this Act is enacted without review and evaluation by the Department 7 of Professional and Financial Regulation, Bureau of Insurance.'

8 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section 9 number to read consecutively.

10 SUMMARY

11 This amendment replaces the bill. The amendment requires health insurance carriers to 12 provide coverage for services provided by certified registered nurse anesthetists if those 13 services are within a certified registered nurse anesthetist's scope of practice and are 14 covered services under a health plan. This amendment makes the requirement applicable 15 to contracts issued or renewed on or after January 1, 2022.
