1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 33 MRSA §469-A, sub-§6**, as enacted by PL 1987, c. 385, §4, is amended
3 to read:

4 **6. Lack of reservation.** Any person owning land in this State abutting a proposed,
5 unaccepted way or portion of a proposed, unaccepted way, whose predecessors in title
6 had not reserved title in the way under subsection 1 or 2, is deemed to own to the center
7 line of the way or portion of the way, except for a proposed, unaccepted way under
8 subsection 6-A.

9 **Sec. 2. 33 MRSA §469-A, sub-§6-A** is enacted to read:

10 **6-A. Bounded by other property.** A person owning land in a subdivision abutting a
11 proposed, unaccepted way or portion of a proposed, unaccepted way owns the entire
12 width of the portion of the way that abuts the person's land if:

13 A. The proposed, unaccepted way or portion of the proposed, unaccepted way is part
14 of the subdivision and is laid out on the subdivision plan recorded in the registry of
15 deeds;

16 B. The person's predecessors in title had not reserved title in the proposed,
17 unaccepted way or portion of the proposed, unaccepted way under subsection 1 or 2;
18 and

19 C. The proposed, unaccepted way or portion of the proposed, unaccepted way is
20 bounded on the opposite side by land that is not included in the subdivision.

21 If the land on the opposite side of a proposed, unaccepted way or a portion of a proposed,
22 unaccepted way under this subsection extends beyond the person's land, then the person
23 owns the entire width of that portion of the extension of the proposed, unaccepted way
24 that is not bounded by another owner's land on the person's side of the way.

25 **SUMMARY**

26 Current law allows a person who owns land that abuts a proposed, unaccepted way
27 ownership to the center line of that proposed way. This bill allows a person who owns
28 land in a subdivision that abuts a proposed, unaccepted way to own the entire width of the
29 way if the land on the opposite side of the way is not part of the subdivision and allows
30 the person to own an extension of that portion of the way beyond the boundary of the
31 person's land that is not bounded by another owner's land on the person's side of the way.
