16 17 18 19	'Sec. 1. Task Force To Study the Establishment of the Office of the Education Ombudsman established. Resolved: That the Task Force To Study the Establishment of the Office of the Education Ombudsman, referred to in this resolve as "the task force," is established.
20 21	Sec. 2. Task force membership. Resolved: That, notwithstanding Joint Rule 353, the task force consists of 14 members appointed as follows:
22 23 24	1. Three members of the Senate, appointed by the President of the Senate, with 2 members representing the party holding the largest number of seats in the Senate and one member representing the party holding the 2nd largest number of seats in the Senate;

Three members of the House of Representatives, appointed by the Speaker of the House, with 2 members representing the party holding the largest number of seats in the House of Representatives and one member representing the party holding the 2nd largest number of seats in the House of Representatives;
29	3. The following members appointed by the President of the Senate:
30	A. A member representing a statewide association of educators;

4. The following members appointed by the Speaker of the House: 1 2 A. Two student members, one of which must represent a traditionally underrepresented minority group. Both members must be selected from or recommended by the 3 Department of Education's Student Cabinet, the State Board of Education or a 4 statewide association of student council members: 5 6 B. A member of the Permanent Commission on the Status of Racial, Indigenous and Maine Tribal Populations established under the Maine Revised Statutes, Title 5, section 7 25001; and 8 9 C. Duties. Resolved: That the task force shall study how to establish the office 23 of the education ombudsman, which must include the following: 24 1. The qualifications for the education ombudsman, which must include that the ombudsman be a person of recognized judgment, independence, objectivity and integrity 25 26 and must be qualified by training or experience or both in public education law and policy 27 in this State, dispute resolution or problem resolution techniques, including mediation and negotiation, and community outreach. The ombudsman may not be an employee of a school 28 administrative unit or the Department of Education or other state agency while serving as 29 education ombudsman; 30 2. The powers and duties of the education ombudsman, which must include: 31 32 A. Providing information to students, parents and interested members of the public regarding the State's public school system; 33

> and racial minority students and students with disabilities identified as having disproportionately lower academic achievement;

> B. Identifying obstacles to greater parent and community involvement in shared school decision-making processes and recommending strategies for helping parents and

> community members to participate effectively in shared school decision-making

processes, including understanding and respecting the roles of school administrators

Resolved: That, notwithstanding Joint Rule 353, the task force shall submit a report that includes its findings and recommendations, including suggested legislation, to the Joint Standing Committee on Education and Cultural Affairs no later than January 30, 2022. The Joint Standing Committee on Education and Cultural Affairs may report out a bill related to the report to the Second Regular Session of the 130th Legislature.'

24	SUMMARY
25 26 27 28 29 30 31	This amendment, which is the majority report of the committee, replaces the bill with a resolve that establishes a legislative task force to study how to establish the office of the education ombudsman, including the qualifications for the ombudsman, the ombudsman's duties and powers, the definition of the role of the ombudsman, where the office should be sited and the processes for reporting, communication, relationships, handling of concerns and complaints, connection with the Department of Education customer care systems, management of privacy and confidentiality and messaging to school districts.
