COMMITTEE AMENDMENT “ ” to H.P. 1178, L.D. 1589, “An Act To Ensure Equity in the Cannabis Industry”

Amend the bill by striking out the title and substituting the following:

'An Act To Ensure Equity in the Membership of the Marijuana Advisory Commission'

Amend the bill by striking out everything after the enacting clause and inserting the following:

'Sec. 1. 28-B MRSA §902, sub-§1, as enacted by PL 2017, c. 409, Pt. A, §6, is amended to read:

- 1. Membership.** The commission consists of the following ~~15~~ 21 members:
 - A. Two members of the Senate, including members from each of the 2 parties holding the largest number of seats in the Legislature, appointed by the President of the Senate;
 - B. Two members of the House of Representatives, including members from each of the 2 parties holding the largest number of seats in the Legislature, appointed by the Speaker of the House of Representatives;
 - C. The Commissioner of Administrative and Financial Services or the commissioner's designee;
 - D. The Commissioner of Agriculture, Conservation and Forestry or the commissioner's designee;
 - E. The Commissioner of Health and Human Services or the commissioner's designee;
 - F. The Commissioner of ~~Labor~~ Economic and Community Development or the commissioner's designee;
 - G. The Commissioner of Public Safety or the commissioner's designee;
 - H. The following ~~3~~ 6 members, appointed by the President of the Senate:
 - (1) A representative of a statewide association representing prosecutors;

- 1 (2) A representative of a statewide association representing the medical marijuana
- 2 industry; ~~and~~
- 3 (3) A member of the public; ~~and~~
- 4 (4) A member of the public with demonstrated expertise in the cultivation of
- 5 marijuana or the manufacturing of marijuana concentrate and marijuana products;
- 6 (5) A representative of a statewide association representing defense attorneys; and
- 7 (6) A representative of a statewide civil rights organization with a primary mission
- 8 to advance racial equity and racial justice; and

9 I. The following ~~3~~ 6 members, appointed by the Speaker of the House of
10 Representatives:

- 11 (1) A representative of a statewide association representing the adult use marijuana
- 12 industry;
- 13 (2) A member of the public with demonstrated expertise and credentials in public
- 14 health policy; ~~and~~
- 15 (3) A member of the public; ~~and~~
- 16 (4) A qualifying patient;
- 17 (5) A member of a federally recognized Indian tribe in the State; and
- 18 (6) A representative of the state chapter of a national civil liberties organization.

19 For all appointments under paragraphs A, B, H and I, an effort must be made in making the
20 appointments to represent the racial and gender diversity of the State.

21 **Sec. 2. 28-B MRSA §902, sub-§5**, as enacted by PL 2017, c. 409, Pt. A, §6, is
22 amended to read:

23 **5. Quorum.** A quorum of the commission consists of ~~8~~ 11 members.'

24 Amend the bill by relettering or renumbering any nonconsecutive Part letter or section
25 number to read consecutively.

26 **SUMMARY**

27 This amendment replaces the bill, which is a concept draft. It changes the membership
28 of the Marijuana Advisory Commission established under the Maine Revised Statutes, Title
29 28-B, section 901 by removing the Commissioner of Labor, adding the Commissioner of
30 Economic and Community Development and adding 6 members representing certain
31 interests, to be appointed by the President of the Senate and the Speaker of the House,
32 increasing the number of members from 15 to 21.
