1	9. Curbside pickup. A marijuana store may allow curbside pickup of immature
2	marijuana plants, seedlings, adult use marijuana and adult use marijuana products at a
3	designated location outside of the marijuana store in accordance with the requirements of
4	this subsection and any additional requirements imposed by the department by rule.
5	A. A marijuana store that allows curbside pickup of immature marijuana plants,

7	curbside pickup location outside of the marijuana store and near the entrance to the
