Consistent with rules adopted by the commission pursuant to subsection 4, the commission may order or provide funding in accordance with subsection 3 to an intervenor in a commission proceeding or to an advocate in a legislative proceeding upon a finding that:

With respect to an advocate, the advocate is likely to substantially contribute to the legislative proceeding by presenting a position different from the Office of the Public Advocate and commission staff and participation in the legislative proceeding by the advocate would impose a significant financial hardship on the advocate.
5 6 7 8	3. Funding sources. If the commission finds pursuant to subsection 2 that an intervenor in a commission proceeding or an advocate in a legislative proceeding qualifies for funding, the commission may, consistent with rules adopted by the commission pursuant to subsection 4:
