If the number or length of referendum questions to be submitted to the voters at the general election in November 2016 requires the production and delivery of more than a single ballot by the Secretary of State, the State Controller by August 1, 2016 shall transfer from the unappropriated surplus of the General Fund to the Department of the Secretary of State.

5	SUMMARY
6	This amendment reduces the amount of the bond issue for the grant program to invest
7	in projects that contribute to economic activity, environmental protection and community
8	development along the State's waterfronts. This amendment specifies that the projects
9	pertain to the State's ocean and river waterfronts. This amendment also provides for a
10	transfer to the Secretary of State if the number or length of the referendum questions to be
11	submitted to the voters at the general election in November 2016 requires the Secretary of
12	State to produce and distribute more than one ballot to accommodate those questions.
