#### SUMMARY

21 This amendment, which is the majority report of the committee, strikes and replaces the bill. The amendment authorizes the Commissioner of Agriculture, Conservation and 22 Forestry to allow an animal that is a member of an amenable species, a term defined in 23 the amendment, that is owned by a person to be slaughtered and processed at the home of 24 25 another person that is registered to do so if that animal is not being offered for sale by the owner or by any other person. The amendment also adds registered establishments to 26 slaughter establishments that may be periodically reviewed by inspectors to ensure that 27 the laws and rules governing slaughter facilities are being followed. 28
