25 SUMMARY

Current law requires the Department of Health and Human Services to provide for the delivery of federally approved Medicaid services to a qualified woman during her pregnancy and up to 60 days following delivery when a woman's family income is equal to or below 200% of the nonfarm income official poverty line. This amendment, which is the majority report of the committee, extends this coverage to up to 12 months following delivery for the period from January 1, 2022 until December 31, 2026.

Current law also requires the Department of Health and Human Services to provide for the delivery of federally approved Medicaid services to a person who is a noncitizen legally admitted to the United States to the extent that coverage is allowable by federal law if the person is a woman during her pregnancy and up to 60 days following delivery or a child under 21 years of age. This amendment extends this coverage to a woman to up to 12 months following delivery.

Finally, this amendment requires the Department of Health and Human Services to report annually to the joint standing committee of the Legislature having jurisdiction over health and human services matters, beginning February 1, 2023 and until February 1, 2026,
