1 2 3	Sec. 1. Commission established. Resolved: That, notwithstanding Joint Rule 353, the Commission To Study the Adequacy of Housing Safety Laws, referred to in this resolve as "the commission," is established; and be it further
4 5	Sec. 2. Commission membership. Resolved: That the commission consists of 10 members appointed as follows:
6	1. Two members of the Senate appointed by the President of the Senate;
7 8	2. Two members of the House of Representatives appointed by the Speaker of the House;
9	3. The State Fire Marshal or the State Fire Marshal's designee;
10 11	4. One municipal chief of police from a municipality whose population is greater than 20,000, appointed by the Speaker of the House;
12 13	5. One municipal fire chief from a municipality whose population is greater than 20,000, appointed by the President of the Senate;
14 15	6. One municipal code enforcement officer from a municipality whose population is greater than 20,000, appointed by the Speaker of the House;
16 17	7. A member of the public who owns multiple multifamily residential buildings, appointed by the President of the Senate; and
18 19	8. An attorney licensed in this State with familiarity in housing safety policy and law, appointed by the Speaker of the House; and be it further
20 21 22	Sec. 3. Chairs. Resolved: That the first-named Senate member is the Senate chair and the first-named House of Representatives member is the House chair of the commission; and be it further
23 24 25 26 27 28 29	Sec. 4. Appointments; convening of commission. Resolved: That all appointments must be made no later than 30 days following the effective date of this resolve. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been completed. If 30 days or more after the effective date of this resolve a majority of but not all appointments have been made, the chairs may request authority and the Legislative Council may grant authority for the commission to meet and conduct its business; and be it further
30 31 32 33	Sec. 5. Duties. Resolved: That the commission shall meet 4 times to study the housing safety laws, including landlord and tenant relations and rights, the eviction process, bank foreclosure actions on abandoned property and rental housing fire safety issues, and make recommendations for necessary changes; and be it further
34 35	Sec. 6. Staff assistance. Resolved: That the Legislative Council shall provide necessary staffing services to the commission; and be it further

1 Sec. 7. Report. Resolved: That, no later than December 6, 2017, the commission 2 shall submit a report that includes its findings and recommendations, including suggested 3 legislation, for presentation to the Joint Standing Committee on Veterans and Legal 4 Affairs. The Joint Standing Committee on Veterans and Legal Affairs may submit a bill 5 related to the report to the Second Regular Session of the 128th Legislature.

SUMMARY

7 This resolve establishes the Commission To Study the Adequacy of Housing Safety 8 Laws. The commission is charged with studying the housing safety laws, including 9 landlord and tenant relations and rights, the eviction process, bank foreclosure actions on 10 abandoned property and rental housing fire safety issues, and making recommendations 11 for any necessary changes. The commission is required to submit a report containing its 12 findings and recommendations to the Joint Standing Committee on Veterans and Legal 13 Affairs by December 6, 2017.
