# 1 Be it enacted by the People of the State of Maine as follows:

Sec. 1. 7 MRSA §3939-A, sub-§2, as enacted by PL 2007, c. 439, §23, is amended to read:

4 2. Detrimental to health. If a licensed veterinarian or licensed veterinary technician 5 as defined in Title 32, section 4853 determines that a dog or cat is too sick or injured or that it would otherwise be detrimental to the health of the dog or cat to be spayed or 6 neutered within 30 days of placement, the animal shelter or rescue group shall collect a 7 8 deposit of not less than \$50 and not more than \$150 at the time of sale or placement. The 9 animal shelter or rescue group shall determine the amount of the deposit based on the cost of spaying or neutering within the geographic area served by the animal shelter or rescue 10 group. A person accepting ownership of the dog or cat under this subsection shall sign an 11 agreement to have the animal sterilized as soon as it is medically advisable. 12

Upon receipt of proof of sterilization, the animal shelter or rescue group shallimmediately and fully refund the deposit.

The Legislature finds and declares that the public health, safety and welfare of the State of Maine requires the exercise of the police powers of this State to safeguard the people of Maine from incompetent, dishonest or unprincipled practitioners of veterinary medicine by ensuring the delivery of competent veterinary medical care and further that the right to practice veterinary medicine is a privilege conferred by legislative grant to persons possessed of personal and professional qualifications <u>specified in this chapter</u>.

Examinations.** Examinations, written or practical, must be prepared to 15 measure the competence of an applicant to engage in the practice of veterinary medicine. 16 The board may also test an applicant's knowledge of the laws and rules relating to the 17 practice of veterinary medicine. The board may require successful completion of an 18 equivalency examination or assessment mechanism for foreign educated and trained 19 applicants that is designed to evaluate educational equivalence, including clinical 20 competencies and a command of the English language.

The board may employ and cooperate and contract with an organization or consultant in the preparation, administration and grading of an examination, but retains sole discretion and responsibility for determining which applicants have successfully passed the examination. The applicant shall pay the examination fee as set under section 4863-A.

3. Temporary permit. The board may issue without examination a temporary
 permit to practice veterinary medicine in this State to a qualified applicant for license
 pending examination. A temporary permit issued pursuant to this subsection expires the
 day after the notice of results of the first examination given after the permit is issued.
 The applicant shall pay the temporary permit fee set under section 4863-A.

30 4. Permit for performance of relief veterinary service. The board may issue without examination a permit to perform relief veterinary service in this State to a 31 qualified person who holds a doctorate degree in veterinary medicine from an approved 32 veterinary medicine program that is recognized by the United States Department of 33 Education and by the board or by rules of the board applicable to foreign educated 34 35 graduates, and who holds a current license for the practice of veterinary medicine issued by another state, United States territory, province of Canada or other jurisdiction. The 36 board may establish, by rule, the application process. The initial term of a permit issued 37 38 under this subsection may not exceed 30 days. An animal health <u>A veterinary</u> assistant may, under the direct supervision of a licensed veterinarian or a registered <u>licensed</u> veterinary technician, perform duties of an animal health care nature<del>. The duties do not include</del> <u>excluding</u> diagnosing, making prognoses, performing surgery<del>, interpreting laboratory tests</del> or prescribing <del>or initiating</del> treatment.

A veterinarian <u>or licensed veterinary technician</u> whose license is revoked or suspended <del>or a veterinary technician whose registration is revoked or suspended</del> may, at the discretion of the board, be relicensed<del>, reregistered</del> or reinstated at any time without an examination by majority vote of the board on written application made to the board showing cause justifying the relicensing<del>, reregistration</del> or reinstatement.

- 20 2. Assumed responsibility. Has assumed responsibility for making medical

3. Knowledge of patient. Has sufficient knowledge of the patient to initiate a
 preliminary diagnosis of the medical condition of the patient and has personal knowledge
 of the keeping and care of the patient as a result of:

- 25 <u>A. A timely examination of the patient by the veterinarian; or</u>
- B. A medically appropriate and timely visit or visits by the veterinarian to the patient
   while that patient is under the care of the veterinarian's practice;
- 4. Follow-up evaluation. Is readily available for follow-up evaluation or has
   arranged for veterinary emergency coverage and continuing care and treatment; and
- 30 **5. Records.** Maintains patient records.

# SUMMARY

- 32 This bill makes the following changes to the Maine Veterinary Practice Act.
- 33 1. It amends the legislative findings section to update the language.

- 1 2. It changes the designation of "animal health assistant" to "veterinary assistant" and 2 fixes cross-references.
- 3 3. It defines "patient" as an animal or group of animals examined or treated by a veterinarian.
- 5 4. It amends the definition of "practice of veterinary medicine."
- 6 5. It establishes a definition of "practice of veterinary technology."
- 6. Currently, veterinary technicians are registered under state law; this bill requires
  that veterinary technicians be licensed and fixes cross-references.

9 7. It eliminates the Maine State Board of Veterinary Medicine's authority to issue a 10 temporary permit to a qualified applicant for a veterinary license pending examination, 11 and it authorizes a licensed veterinarian or a licensed veterinary technician to practice for 12 no more than 30 days in the State upon the request of the state veterinarian.

8. It requires that, in order to take the licensing examination for veterinary
technicians, the applicant must have completed the professional education requirements
for licensure or be within the final 6 months of professional study in an approved
program of education.

- 17 9. It removes the prohibition against a veterinarian's association for the joint practice
  18 of veterinary medicine with any person, corporation or partnership not licensed to
  19 practice veterinary medicine.
- 10. It updates language outlining the duties of licensed veterinary technicians and
   veterinary assistants.
