5	the Permanent Commission on the Status of Racial, Indigenous and Maine Tribal
6	Populations to submit a report, no later than January 15, 2022, to the Joint Standing
7	Committee on Health and Human Services. It authorizes the committee to report out
8	legislation to the Second Regular Session of the 130th Legislature related to the report.
