Allison Smith and I am one of the leaders of the faith-based movement called Neighbors Need ME. I live in Harpswell, ME and I am testifying in support of LD 3. Four weeks ago people of faith from all across Maine came together as "Neighbors Need ME" because our neighbors wherever they live in Maine are facing unprecedented desperation and the Senate and House are able to help. It is cold. People are not able to find wood or pay for the next 100 gallons of oil. And many (at least 8500 families) literally have nowhere to go as rental assistance funds end. The shelters are full. The overflow warming center is full. As you know, most of our communities don't have homeless shelters.

Because of this crisis 770 clergy, individuals, churches, synagogues, non-profits, organizations signed a letter calling on your support of this bill which I emailed to President Jackson and Speaker Talbot Ross on Swearing In Day. People of faith from Fort Kent to Lewiston to Sanford are asking you to support LD 3 and help our neighbors.

I urge you with people of faith and goodwill all across Maine to pass LD 3 immediately. Our neighbors need us to help--like the mom from Pittsfield with five children who emailed us after hearing of Neighbors Need ME. On Dec. 31 she is going to be on the street with nowhere to go because the shelter cannot take a family that large. Or what about the families in Oxford sleeping in cars or a woman in Cherryfield trying to stay warm in a poorly insulated Home Depot shed? Or what about the young couple who have an 8 month old or another who has a 12 month old. How do these babies survive outside? The family shelter has been full for two years. We have fielded more calls from people all over Maine this year than any other year. We are now out of wood. Last month we delivered a cord of wood to a woman in Gray who was heating her house with her oven. These are our neighbors!

I urge you, as you have identified, to work immediately on a coordinated long-term solution! We have got to find sustainable housing solutions by April because as you know, it is still cold in April.
