Recovery housing exists within both crises, remedying at once the need for treatment programs and safe housing for those in recovery. These programs need more funding and support, not more pressure and restrictions. Realistically, if LD 109 passes, that could mean that recovery houses that provide essential care and housing could be forced to close. Mainers cannot afford to lose any of these safe and effective places for recovery.

I believe residents are safe in houses that adhere to the existing Sec. 1. 25 MRSA §2452, sub-§4, and they are certainly much safer than if recovery houses close and they are forced onto the street. Therefore, I do not see this act creating more safety, it's far more likely it will take away safety from those living in recovery housing.
