A recent survey also shows that <u>more than eight in ten</u> current youth e-cigarette users vape flavored products, with fruit, candy and dessert flavored products as some of the most popular [2]. And according to the <u>Food and Drug Administration</u>, "youth smokers are more likely to use menthol cigarettes than any other age group"[3].

Tobacco addiction damages peoples' health and well-being, and it's an unnecessary strain on employers who already struggle to find reliable staff. Every year, smoking costs Maine nearly \$1.5 billion due to associated health care expenses and lost productivity.
